AMENDMENT NO. 1 TO COOPERATION AGREEMENT

THIS AGREEMENT entered into this day of , 1968, by and between the PROVIDENCE REDEVELOPMENT AGENCY, a public body, corporate and politic of the State of Rhode Island (hereinafter called the "Agency") and the CITY OF PROVIDENCE, a municipal corporation of the County of Providence, State of Rhode Island (hereinafter called the "City").

WITNESSETH:

WHEREAS, on the 25th day of October , 1963, the Agency and the City did enter into a certain agreement entitled Cooperation Agreement which Agreement pertained to the Weybosset Hill Project No. R. I. R-7; and

WHEREAS, the parties hereto have decided it is to their respective mutual advantage and benefit that certain amendments be made in the aforementioned Cooperation Agreement.

NOW, THEREFORE, it is hereby agreed by and between the parties hereto on their own behalf and on behalf of the U. S. Government as follows:

1. That Paragraph 3.A.2. at Page 5 of said Agreement be and the same is hereby deleted.

In lieu of the aforementioned sub-paragraphs the following is substituted thereof:

"The City at its own expense shall construct an addition to the Central Police and Fire Stations which is located within the project area. The parties hereto further agree that the current estimated cost of the aforementioned addition is \$1,000,000 and that twenty five (25%) per cent of the aforementioned addition shall be considered as a non-cash grant-in-aid furnished by the City under the provisions of this Agreement."

2. That Paragraph 2.B.1. at the bottom of Page 5 and at the top of Page 6 of said agreement be and the same is hereby deleted, and the following is substituted therefor:

"The City shall furnish the Agency with the sum of Two Million Eight Thousand Nine Hundred Seventy Four (\$2,008,974.00) Dollars on request and

the Government shall be under no obligation to make any payment on account of the Project Temporary Loan or the Project Capital Grant under this Agreement until the said sum of Two Million Eight Thousand Nine Hundred Seventy Four (\$2,008,974.00) Dollars has been provided by the City towards its estimated one-third share of the Net Project Cost."

The foregoing Cooperation Agreement be and is hereby ratified and confirmed in all other respects.

ect Area.


Since this is located in part of the Weybosset Hill Project and it

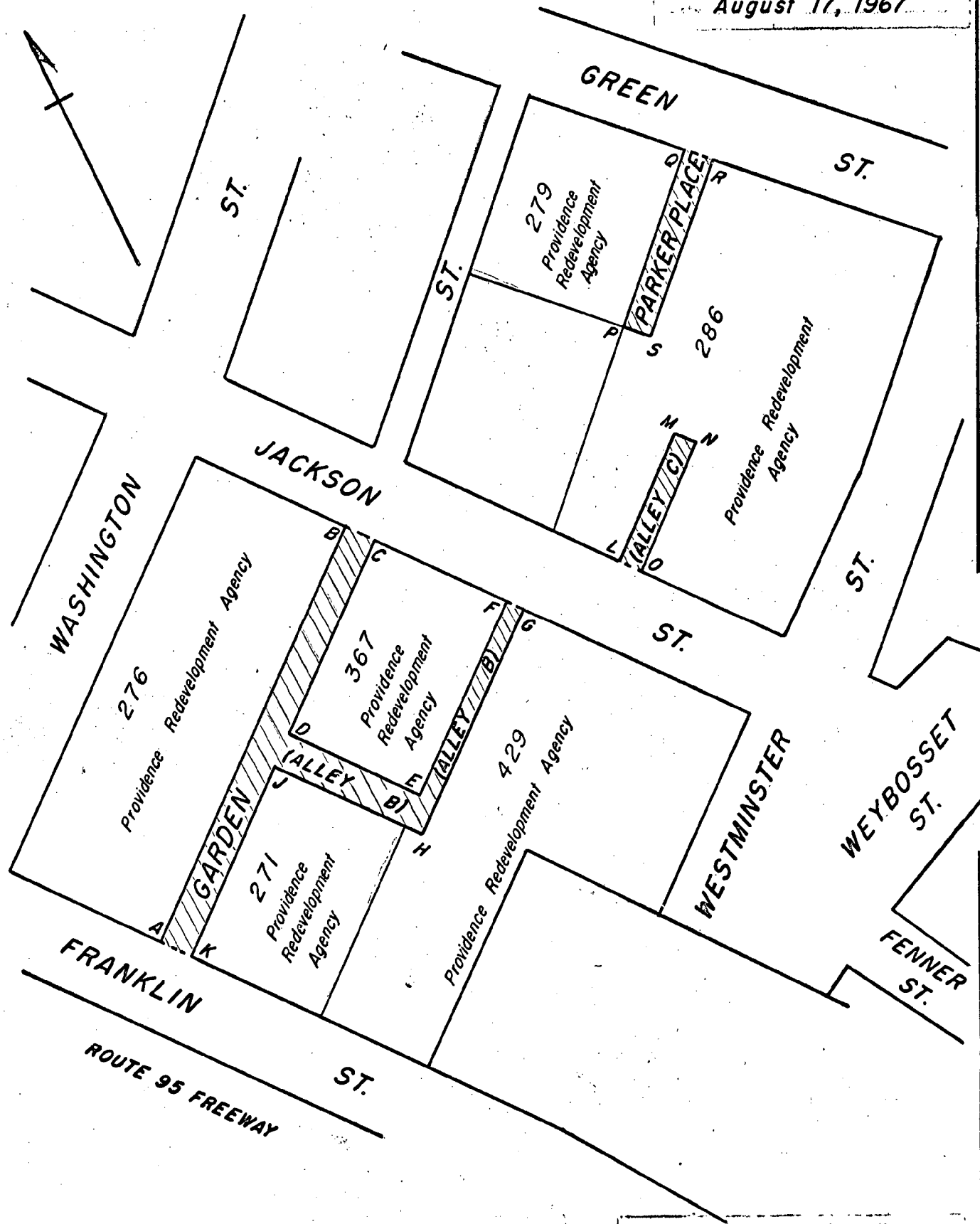

ORDERED:

That the following named high-
ways and unnamed gangways
shown as crosshatched areas on
the accompanying plan, entitled,
"Providence, Rhode Island, Depart-
ment of Public Works-Engineering
Office, Street Line Section Map
No. 063123. Dated July 17, 1967,"

viz:
PARKER PLACE, from the south
westerly line of Greene Street
southwesterly to its termination;
UNNAMED GANGWAY, (Alley
C), so named on the condemna-
tion plan, from the northeast-
erly line of Jackson Street north-
easterly to its termination;
GARDEN STREET, (Portion)
from the northeasterly line of
Franklin Street northeasterly to
the southwesterly line of Jackson
Street; UNNAMED GANGWAY
(Alley B), so named on the
condemnation plan, from the
southwesterly line of Jackson
Street southwesterly to its termi-
nation thence turning and run-
ning northwesterly to the south-
