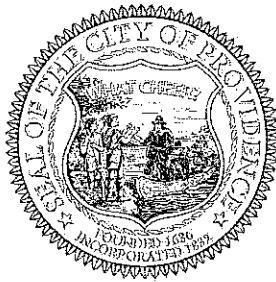

### **COUNCIL PRESIDENT APONTE, (By Request):**

An Ordinance Relating to Article IV, Chapter 17, Section 17-192(F) of the Code of Ordinances. (Disability Waiver Request)

SECTION 1. Notwithstanding the language of Section 17-192(F) of the Code of Ordinances which provides that the application to accomplish such [accidental disability] retirement must be filed within eighteen (18) months of the date of the accident, the Retirement Board of the City of Providence, shall consider and act upon the accidental disability retirement application of Oliver Andrews, even though more than eighteen (18) months have passed since the date of the accident which is the averred proximate cause of the above-named applicant for a disability retirement allowance.

SECTION 2. Said application shall be subject to and considered in accordance with all other applicable ordinances, regulations, standards and practices relating to accidental disability retirement applications.

SECTION 3. This Ordinance shall take effect upon its passage.

**WHEREAS**, Governor Gina M. Raimondo has proposed Rhode Island's Promise, a commitment to provide every student with a two year scholarship to attend the Community College of Rhode Island, Rhode Island College, and the University of Rhode Island; and

**WHEREAS**, This program will make it possible for Providence's high school graduates to earn an associate degree tuition free at the Community College of Rhode Island and will cut the cost of a four-year degree at Rhode Island College or the University of Rhode Island in half; and

**WHEREAS**, The cost of college creates a barrier that keeps college-qualified students from applying for and enrolling in college; and

**WHEREAS**, Governor Raimondo's proposal will make it possible for Providence high school graduates to go to college, regardless of family income; and

**WHEREAS**, Rhode Island's Promise is designed to boost enrollment, improve the graduation and retention rates and will encourage and make it possible for more students to complete their degrees on time; and

**WHEREAS**, A college degree is the surest ticket to the middle class and having a college degree has been shown to increase lifetime earnings, community engagement, and quality of life; and

**WHEREAS**, The Providence City Council believes that this program is in the best interest of the citizens and voters of the City of Providence.

**NOW, THEREFORE, BE IT RESOLVED**, That the City Council of the City of Providence does hereby provide the strongest possible endorsement to the Rhode Island's Promise program and urges the Providence delegation to the General Assembly to work diligently toward its passage..

**RESOLVED**, That His Honor, the Mayor, is hereby authorized to execute a Consent Agreement with the Department of Environmental Management ("RIDEM") to address the City's failure to comply with the series of directives from RIDEM regarding the City's Rhode Island Pollutant Elimination System General Permit, entitled "Storm Water Discharge from Small Municipal Separate Storm Sewer Systems" ("MS4"). RIDEM is prepared to issue a Notice of Violation ("NOV") which would compel the City to pay \$175,000 in penalties for these MS4 failures. However, as an alternative, the City has negotiated the attached Consent Agreement, which avoids the NOV and allows the City to expend the funds which would otherwise be charged as penalties towards other Supplementary Environmental Projects which would partially address the MS4 concerns and complete environmental remediation projects in several City wards.


