Approved November 23, 2004

Where as, in an effort to convert vacant lots into productive reuse, the Providence Redevelopment Agency is working with a neighboring property owner who will develop the lot as a yard and parking.

Now therefore, be it resolved that the taxes, in the amount of Two Thousand Five Hundred Forty Six and Eighty Four Cents (\$2, 546.84), assessed upon Assessor's Plat 48, Lot 957 (21 Salisbury Street), along with any associated interest, penalties and intervening taxes, are hereby abated in whole in accordance with Rhode Island General Law 44-7-23 and that the property is declared exempt in accordance with Rhode Island General Law 45-32-40.


