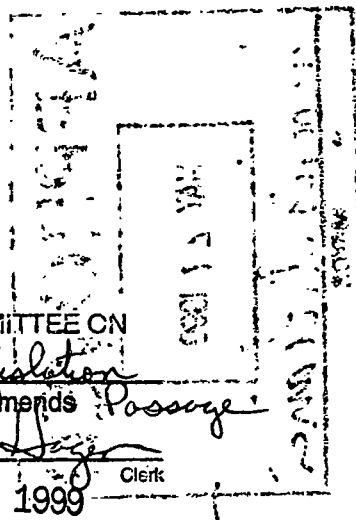


This Senate Bill has been introduced by Senators Ruggerio, Kells, Igliozzi, Perry, Caprio, et al. This act would place a four (4) year moratorium on the issuance of adult entertainment licenses within the City of Providence.

This amendment to the general law would read: 45-2-23.1 City of Providence -Bureau of Licenses - Moratorium.-- the Bureau of licenses within the City of Providence, shall not issue, to any establishment which is not an operating business as of February 1, 1999, any adult entertainment licenses or any entertainment licenses that would permit adult entertainment for a period of four (4) years from the effective date of this section.

I am requesting that a resolution in support of Senate Bill 99-S-0384 with regard to this moratorium be placed in the next docket of the Providence City Council.
