In accordance with Sections 302(f) and 412 of the Providence Home Rule Charter of 1980, I hereby disapprove and veto the attached ordinance entitled AN ORDINANCE AMENDING CITY OF PROVIDENCE ORDINANCE CHAPTER 17, SECTION 17-33, ENTITLED: "STANDARD OF CONDUCT OF EMPLOYEES."

I have taken this action because the ordinance is clearly confusing if not contradictory. It proscribes an activity in its first sentence which it exempts in the second sentence, essentially rendering the proscription a nullity. Additionally, even if such a proscription were to be established, it would have minimally salutary effect when weighed against its purpose — to inform the taxpayers of the obvious.

Dear Mr. Clerk:

In accordance with Sections 302(f) and 412 of the Providence Home Rule Charter of 1980, I hereby disapprove and veto the attached ordinance entitled AN ORDINANCE IN AMENDMENT OF AND IN ADDITION TO CHAPTER 17 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE BY ADDING SECTION 17-34, ENTITLED: "STANDARD OF CONDUCT OF ELECTED OFFICIALS."

I have taken this action because the Rhode Island Campaign and Expenditures Reporting Act (R.I.G.L. Section 17-25-1, et seq.) already provides for the reporting of contributions received to aid or promote the nomination and election of all candidates for public office. Additionally, this ordinance which provides for the reporting of contributions from business entities would clearly conflict with a provision of state law (R.I.G.L. Section 17-25-10.1[h]) which prohibits *any* contributions from business entities of any type. To adopt a municipal ordinance which regulates an activity already *prohibited* by state law is not only illogical but illegal, in that it would constitute an invasion by a municipality on the power reserved

to the General Assembly by Article IV of the State Constitution.
