Gentlemen:

This department has reviewed the following resolution from your Committee and has taken the subsequent action:

Request: That the Traffic Engineer is requested to undertake a study of the present traffic along Seabury Street and along Grand Street, for the purpose of proposing the establishment of an alternating pattern of one way motor vehicle traffic.

Disposition: This department offers no objection to establishing Seabury Street as a one way street in a southerly direction from Potters Avenue to Huntington Avenue, and establishing Grand Street as a one way street in a northerly direction from Huntington Avenue to Potters Avenue. However, I suggest that a petition be obtained from all of the residents of Seabury Street and Grand Street indicating their desire for such a one way traffic pattern.
