WHEREAS, There exists within certain voting districts within the various Wards in the City of Providence inconsistencies in the size of voting districts relative to the number of persons registered in said districts, and

WHEREAS, According to the General Laws of the State of Rhode Island, Section 17-11-1 Division of towns and representative district into voting districts, 16 districts within the City are either over or under the prescribed limit, and

WHEREAS, In an attempt to reduce the number of polling places within the City while creating greater economies the City finds itself unable to proceed due to the fact that correcting these inconsistencies would involve senatorial and representative, as well as Ward boundary lines, and

WHEREAS, It is the responsibility of the General Assembly to amend General Assembly lines, and

WHEREAS, These corrections cannot be accomplished without General Assembly action,

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence requests that the General Assembly study this matter and attempt to correct the inconsistencies.




