

RE: ALMIRA AND SISSION STREETS - FOUR WAY STOP CONTROL

REQUEST: To establish a four-way STOP control at the intersection of Almira Street and Sission Street.

DISPOSITION: Denied. This intersection does not meet any of the warrants for the installation of a four-way stop control as set forth in the Manual on Uniform Traffic Control Devices, with regard to high accident frequency and high traffic volumes. A STOP control is not to be used as a method of speed control.






Vinyl Siding All Ready There
