Pursuant to Sections 302(f) and 412 of the Providence Home Rule Charter of 1980, I have disapproved and vetoed the following separate items:

APPROPRIATIONS ORDINANCE

I. With reference to An Ordinance in Amendment of Chapter 2002-50, Approved October 29, 2001, of the Ordinances of the City of Providence making an Appropriation of Five Hundred Fourteen Million, Nine Hundred Two Thousand, Twenty Seven Dollars (\$514,902,027) for the Fiscal Year Ending June 30, 2003, as Amended, I have vetoed or reduced the following items:

A. *Office of Internal Auditor*

The Salaries line-item is reduced by \$47,089, resulting in a new total for Salaries of \$184,853. The Services line-item is reduced by \$25,000, resulting in a new total for Services of \$0. Consequently, the total amount for the Office of Internal Auditor is reduced by \$72,089, resulting in a new Total of \$184,853. (See also the above-referenced Appropriations Ordinance for the hand-written reductions).

I am taking this action because, in a time of fiscal austerity, the funding of additional positions and consulting services cannot be justified.

B. *P.E.R.A.*

The line-item listed as P.E.R.A. is reduced by \$150,000 resulting in a new total of \$0. (See also above-referenced Appropriations Ordinance for the hand-written reduction).

I am constrained to take this action because P.E.R.A., so-called, is not a legally established entity of city government.

As a result of the above-stated reductions, the Grand Total of the Appropriations Ordinance is reduced from \$514,902,027, resulting in a new Grand Total of \$514,679,938. (See also the above-referenced Appropriations Ordinance for the hand-written reduction).

CLASSIFICATION ORDINANCE

II. With reference to An Ordinance Establishing the Classes of Positions, the Maximum Number of Employees and the Number of Employees in Certain Classes in the City Departments, and Repealing Ordinance Chapter 2001-34, Approved October 29, 2001, as Amended, I have vetoed and reduced the following:

A. *Section 54(a) Office of Internal Auditor.*

The number of positions entitled Assistant to Internal Auditor is reduced from 2 to 1. The position entitled Senior Auditor Analyst is disapproved and vetoed. As a result, the total number of positions in the Office of Internal Auditor is reduced by 2, resulting in a new total of 3 positions. (See also the hand-written reductions in the above-referenced Classification Ordinance).

I have taken this action to be consistent with the reduction that I have made in the above-referenced Appropriations Ordinance for the Office of the Internal Auditor. (See I. A. above).

B. *Section 64 and Section 65.*

I have vetoed Sections 64 and 65 in their

entirety. (See also the lined-out areas of the above-referenced Classification Ordinance).

I have taken these actions because these Sections tie the hands of department heads when they are confronted with circumstances which, in their judgment, require more flexibility than the Sections permit. These restraints would unnecessarily diminish the ability of the City to deliver services to the public in an effective and timely manner.

COMPENSATION ORDINANCE

III. With reference to An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Ordinance Chapter 2001-51, Approved October 29, 2001, as Amended:

A. I have vetoed the position entitled Senior Auditor/Analyst. (See also the hand-written

deletion in the above-referenced Compensation Ordinance). The deletion of that position is made necessary by its elimination in the Classification Ordinance. (See II. A. above).

B. I have vetoed Section 5 and Section 6 in their entirety. (See also the lined-out areas of the above-referenced Compensation Ordinance). I have taken these actions because these sections are identical with the sections that I have vetoed in the Classification Ordinance. I have vetoed these sections for the same reasons as stated in II. B. above.

PERSONAL EXPRESSION

COUNCILMAN JACKSON Requests the Privilege of the Floor to Speak on a Point of Personal Expression and states:

"Thank you Council President. Again, I would like to thank my colleagues but rise on a point of Personal Privilege because of the disturbing article that was in the Journal Paper today in regards to the School Board not agreeing with the cuts that this Council to solve the school crisis so that the teachers could go back to school with their pay raises and so that the children could return to school on the proper time. It's disturbing to me to see the School Board being opposed to the proposed cuts that we made in the School Department Budget to balance the budget. They presented a budget, let me give you some history. They first presented the Finance Committee that was \$23,000,000.00 in the hole and if some of them had their way when they came and did their presentation. They told the Finance Committee go ahead raise taxes, \$5.83. That will take care

of all our needs. Again, balancing the back, balancing everything on the back of the taxpayers. It was hard enough for all of us who voted for the \$1.25 increase to vote for that. But even with that, that left us with a \$16,000,000.00 budget gap. After hard work and countless hours from the Finance Committee, the Internal Auditor and the Finance Department, we were able almost to balance their budget for them but we're still 2.8 Million Dollars short which was the pay increase, the retro-active pay increase for the teachers and the administrators and that's why we could not immediately pass the teachers and administrators contract. Just to give you an insight to the lack of communication that exists in our School Department. One of the original cuts we made in their budget and this was long before we came up short 2.8 Million was this thing that they called not a new school but a new special education center. That way they could get around some federal handicapping laws and be mindful of those federal handicapping regulations regarding

separation of special education students from the regular population. We should not forget that we were sued because of the old Pleasant School and we are already in a law suit involving a broken elevator and services to a special education student as I speak right now and it was only because of my regular job as being an Educational Advocate for children in DCYF custody that I knew the school was still going as planned because one of my clients was told to report there. I called the Internal Auditor who then gave me Alan Sepe who confirmed, yes, it was being built at the Fogarty Center. When I met with Alex in regards to this, he called Mark Dunham who had on the phone, on the speaker phone had said "I don't have any knowledge of this". But then later got back to me and said "yes, Mr. Swanson was going ahead with it any way". That was a \$498,000.00 cut we made in the budget and somewhere they found \$498,000.00 more to go ahead with this, and not to sound redundant but that's one of the reasons why we needed to add an Internal Auditor just for the School Department alone. After all of this through the leadership of the Council President who brought together the Union, the Administration, the School Board and myself. We were able to work all day on the Thursday and we also left our full-time jobs. I think some times the School Board forgets that to come with real cuts not sports as they had cut, not these emotional cuts that no one can agree to. We had to make real cuts in the City Budget, and we did not like them but too many people have eaten off the City for too long. When you run a business, you can't depend fully on one funding source if that source is the City of Providence. A good Executive Director will have many funding sources so that when one dries up it does not devastate their non-profit corporation. We are a City. We are responsible to the taxpayers. We are not the development directors or fundraising directors for non-profit agencies. The School Board did not come up with one cut and now they feel the pressure of some Social Service Agencies that the City has given money to in

the past that we cut so that our children could return to school so the teachers could have their raises and now they're saying "we don't agree with any cuts the City Council made". We had to make hard decisions and not tax the people at a \$5.83 increase. These agencies have high powered boards and directors who should be able to raise the money cut in one fundraising effort and I'll even tonight pledge to help them raise that money and two, they should have development directors who find the grants and fundraising they need to balance their budgets and stop depending on the City to raise your money. Finally, I don't want this speech to be considered anti-reform as every time we talk about schools and education in the City it is anti schools. Every time that one of the Council members speaks about schools and education, that's what we hear in the paper. We must be anti-reform, we must be anti-school. But I respectfully disagree. In my tenure, with my colleagues on the Council, we have been the most pro-education, the most pro-reform that I've seen in eight years. We've built more schools than anyone in the whole state has combined. We have been the most outspoken leaders for community schools, site based management, smaller communities within our schools. I know that each and every one of us when called upon has solved problems within our own community schools. I myself have seen and heard many of you at School Board Meetings speaking about issues on education. Last year we gave them a \$2.5 Million increase in local aid and this year again when we passed this budget, we gave them a increase in aid. Remember we own this forever, once we increase their local school aid. It is ours forever. But there is one fundamental difference that I see between the School Board and the City Council. That is that they are a single issue Board. They only have to care about education. We must weigh every need of the City of Providence and the taxpayers that we represent. When we are making decisions and when you have a \$23,000,000.00 deficit, you must display courage in making hard decisions

and yes, no one feels pressure more than all of us but our decisions are good decisions. They are the best for the City of Providence and the taxpayers. How about this idea seeing that the School Board doesn't agree with us. The

elimination of the School Board and their salaries and the benefits. Therefore when they can not and will not make decisions then finally the hard work of the Council will be realized. Thank you."

COUNCIL PRESIDENT PRO-TEMPORE BALBINA A. YOUNG IN THE CHAIR

PERSONAL EXPRESSION

COUNCILMAN LOMBARDI Requests the Privilege of the Floor to Speak on a Point of Personal Expression and states:

"It's going to be very difficult to follow that act. Thank you Madam President. I appreciate the accolades that you talked about this evening but it's the collective wisdom of this honorable that certainly inspired me and also the headlines that morning the Majority Leader stated very eloquently. I was probably up at four o'clock that morning and the paper was delivered. Approximately six forty-four and I think his phone rang at six forty-four thirty, I believe but and I can tell that we had just gone through or endeavored to pursue the onerous task of passing a budget which was not palatable to some people on this Council because as my esteem colleague the Chairman of Finance Committee. As the Finance Committee toiled for many, many weeks and months, there was basically a number that was

presented to us and we had to decide and decipher where those monies would be allocated that would best serve the taxpayers of the City of Providence and it read somewhat Council passes budget and then it said something about the School Board. Well I'll tell you and Councilwoman DiRuzzo will appreciate this the best because I anticipated a problem just by the title and my next call was to the Leader. My next call was to Mr. DiCecco. My next call was to Diana Lam through Lucy and I thought that it would behoove us to meet and that's what we did and I started off the meeting very simply and succinctly which was and I think it brought about the consensus which was we are all concerned about the twenty-seven thousand or so pupils that are in the City of Providence because everyone has always stated that very concisely, very succinctly and the next thing I said was that the Chairman of the Finance Committee who's put hundreds of hours into this particular issue and the School Department

alone and myself were prepared to sit there. The meeting started at ten o'clock until five o'clock that evening to get this issue resolved because it was the foremost issue that presented, that was presented to this Council.

We knew how important it would be with a strike and everyone recognized that and everyone agreed and from there consensus. Everyone was in agreement. Everyone around that table. It was unanimous. No one flinched. No one blinked and everybody had something to put on the table and everybody knew that number one, their ego be left outside the door and number two everyone had to be willing to give up something and that's how we approached and that's why you see the budget that is presented. Now it's very disconcerting when you pick up the paper a couple of weeks later and everyone is passing accolades to say "you know your leadership, your leadership, your leadership. With me, it's not about me and my leadership. It was about the ability to bring people around a table and to come to some compromise and some consensus. That's what happened that day and I was walking out and the various heads of the various agencies that were represented said "Mr. President, you know you showed exemplary leadership skills, negotiating skills" and I said, "it's not about

me, it's about the children of the City of Providence". It's about the hard working men and women that teach them. It's about their support staff and it's about the taxpayers in the City of Providence. That's all, leave the ego outside the door. Now you read today's paper and you say "what happen to the consensus?" What happened to the agreement? What about the good faith negotiations? What about the mutually of assent? What about the meeting of the minds? That's what happened that day. That's why this Council voted to pass that because we agreed and if someone is saying "well, you know, it wasn't it writing and so on and so forth, yes. But be mindful of the recent case that came down that's going to cost a corporation hundreds of millions of dollars on a handshake and an oral agreement. So that's the way of the courts but it wasn't about me. I just wanted to let you know that but I'm honored and privileged that you guys, that my esteemed colleagues have recognized me but it's that man in the corner because he sleeps, eats and drinks the concerns of the children in the City of Providence and the taxpayers of the City of Providence so Mr. Chairman, my compliments to you. Thank you very much."

PERSONAL EXPRESSION

COUNCILWOMAN DiRUZZO Requests the Privilege of the Floor to Speak on a Point of Personal Expression and states:

"Point of Personal Expression. I don't want to debate the School Department Budget but I still and I will repeat my concern as you know

I voted against the budget but the cuts that were made in the School Department Budget I would hope as I expressed at the last meeting that I attended that we rethink some of those cuts perhaps shifting some of the cuts around because I am concerned with a lot of the cuts we made that affect the school buildings. In one instance, the maintenance. We don't maintain and we have no budget to maintain our schools as it is. I hate to see that part of the School Department budget cut. But I want to go on to something else. The meeting we discussed the budget before passage. I talked about the Abandoned Car Program in the City, the fact that was called to my attention. That, that budget was cut, it was reduced from a Hundred Thirty Seven Thousand to Fifty Seven Thousand Dollars. Now as you all know and at that meeting I was informed if my memory serves me correctly that that was not the case. But in the meantime since then I have received a letter from the Acting Chief of Police, Colonel Sullivan indicating and also enclosing the copy to me that that budget has indeed been cut and so that that's going to put a very big dent in the Abandoned Car Program. Most of us are very happy to have it. We have cars abandoned all over this City and I've been very proud, I mean I wrote that Junk Car Law many years ago and I'm very proud of it. It's a very good tool that has helped us keep our neighborhoods

clean. Free of harborage for rats. Cars that are left on vacant lots and in peoples yards for years and years and allowed to deteriorate and they're eye soars. So, I'm not very happy to know that that budget has been cut more than half. More than half, more than half so what are we going to do now? We're not going to tow cars, we're going to go back to the same old same old City with all kinds of cars. Junk cars hanging out. That's not the way to do business here. This is a quality of life issue. I need, you need to re-think that cut and we need to restore that money from Fifty Thousand Dollars. We went from One Hundred Thirty Seven Thousand Dollars, that's not a lot of money people. Not with that kind of work that that Tow Squad does to Fifty Thousand Dollars now you're going to handicap them. So I would ask that the Finance Committee re-look, take a good look at that and I'm going to be sure that you all receive a copy of the letter that the Chief of Police has directed to me because Sergeant Gregory who's in charge of that department has done an outstanding job in keeping all of our neighborhoods clean of abandoned cars. This affects all of us not just me."
