

Dear Councilman Lombardi:

The residents of Aaron Briggs Manor, at 301 Cranston Street in Providence, are requesting that a traffic light with a control device for pedestrians be installed in front of our building.

We realize that there is a traffic light with a pedestrian control device at the intersection of Dexter and Cranston Streets. However, this is a very dangerous intersection as drivers do not look for pedestrians crossing; especially when making a right turn on a red light.

Last year, one of our residents was killed while crossing at the intersection of Dexter and Cranston Streets. This year, another resident was hit and injured while crossing in front of Aaron Briggs Manor at Harrison and Cranston Streets.

We feel that this is justification for a traffic light with a pedestrian control device to be installed in front of Aaron Briggs Manor.




RESOLVED, That the Traffic Engineer is requested to replace that missing Street Name Sign of Kinfield Street, at its intersection with Hartford Avenue.
