No. 434 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1981-9 APPROVED MARCH 13, 1981, BY TRANSFERRING CERTAIN SUMS OF MONEY WITHIN THE DEPARTMENT OF PUBLIC SCHOOLS.

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1981-9 of the Ordinances of the City of Providence, as approved March 13, 1981, and entitled: "An Ordinance Making an Appropriation of One Hundred Thirty-Nine Million, Three Hundred Sixty-Four Thousand, Eight Hundred Seventy-Six Dollars (\$139,364,876.00) for the Fiscal Year Ending June 30, 1981" is hereby further amended by transferring certain sums of money within the Department of Public Schools as follows:

Dear Ms. Mendonca:

The Finance Department requests permission to transfer funds within the School Department as follows:

Increase Salaries and Wages \$102,000.00, increase Services Other Than Personal \$461,000.00, while decreasing Materials and Supplies \$470,000.00, Special Items \$55,000.00, and Capital Outlay \$38,000.00. The net effect of these transfers is zero change in the total budget.

Furthermore, the department requests permission to transfer \$31,000.00 from Snow Removal (1-05-10-001) to Street Lighting (1-05-12-132) to pay utility bills. These requests are being sponsored by Councilman Mansolillo.
