2. Attended Providence Public Schools. Was graduated from Mount Pleasant High in 1950 with high honors. Member of the Rhode Island Honor Society.

4. Served in U.S. Marine Corps 1954 to 1958, achieving rank of Captain.
5. 1958 to 1961 attended New York University Law School. Received LLB in 1961.
6. Admitted to the Rhode Island Bar February 1962 and have been actively engaged in the practice of law since then.
7. Elected to the Providence City Council 1962 (Democrat 7th Ward). Served until 1974. Served on most major committees, including chairmanship of Committee on Claims and Pending Suits and Employee Relations Committee. Also served four years as deputy majority leader.
8. 1972 elected to serve as a councilmanic member of the Providence Redevelopment Agency, through 1974.
9. Democratic candidate for mayor for the City of Providence in the Democratic primary of 1974.
10. January 1975 appointed and served as chief counsel to the Providence Redevelopment Agency and the Department of Planning and Urban Development through 1982.
11. The practice of law has included practice before all courts of the State of Rhode Island, Workers' Compensation Commission, most agencies, and the Federal District Court.
