

In order to eliminate the congestion and confusion that is caused by opposing movements of traffic in this narrow section of Peace Street, it is hereby recommended that Peace Street be made one way in a westerly direction from Broad Street to Updike Street.



SUBJECT: Referral No. 1137 - ZONING CHANGE AT 21 RESERVOIR AVENUE

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, January 26, 1960.

This referral is a request to change Lots 4 and 305 on Assessor's Plat 51 from a C-4 Heavy Commercial Zone to an M-1 General Industrial Zone; said lots being situated on the westerly side of and designated as 21 Reservoir Avenue.

On an inspection and photographic survey it was determined that the site contained a one-story masonry building which was vacant and a one-story masonry building which was occupied by an automobile sales and service agency.

Any further extension of less restricted industrial uses in this area is unsuitable as it would add considerably to existing traffic congestion and traffic hazards at a bad traffic intersection. Columbus Square although small in area has historical significance and is identifiable with civic activities and origin of public affairs. Land use pattern changes will immediately affect this commercial area adversely and, therefore,
