Revere Place shown as cross-hatched area on the accompanying plan and designated by the letters (A-B-C-D-A), having ceased to be useful to the public and the same is proposed to be abandoned as a Public Highway, and the damage to the abutters is appraised at nothing and so awarded, and it is further,

ORDERED, That the Traffic Engineer, be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, That after the entry of this order or decree, the City Clerk shall cause a notice, thereof, to be published in a newspaper published in the County of Providence at least once a week for three successive weeks, and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.

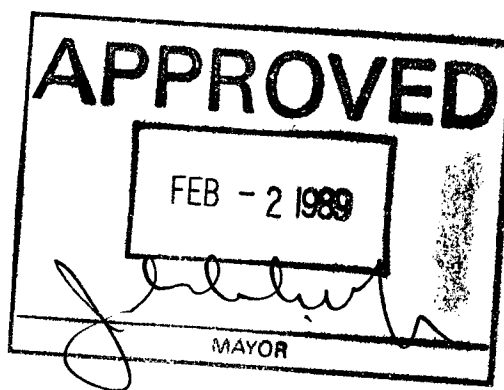
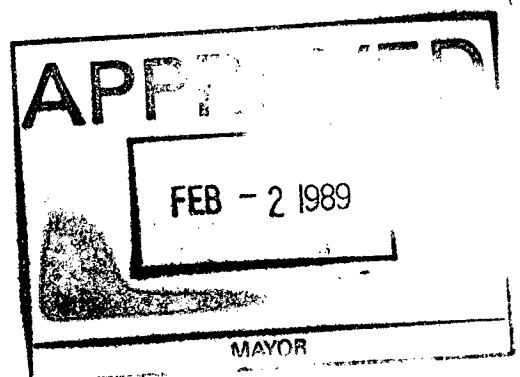

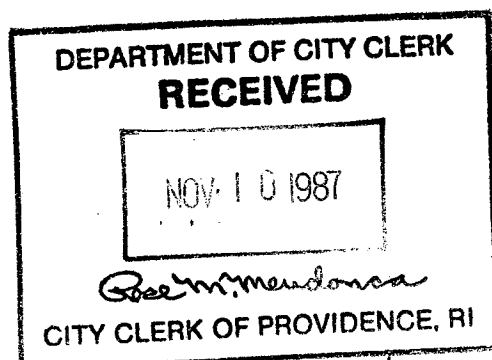

DESCRIPTION OF A PARCEL OF LAND

KNOWN AS REVERE PLACE

Beginning at a point on the southerly line of Orms Street in the City of Providence. Said point being the intersection of the southerly line of Orms Street and the easterly line of Revere Place as shown on Plat Card 1109 entitled "Map of Lots in Providence, RI belonging to Alex Johnson", dated May 1923.

Thence southerly along the easterly line of Revere Place for a distance of 188.11 feet to a point.

Thence turning westerly at an interior angle of $87^{\circ}-44'-46''$ for a distance of 20.06 feet to a point.

Thence turning northerly at an interior angle of $92^{\circ}-15'-14''$ for a distance of 193.16 feet to a point. This being on the southerly line of said Orms Street.

Thence turning easterly along the said street line at an interior angle of $73^{\circ}-45'-35''$ for a distance of 20.89 feet to a point of beginning.

Gentlemen:

The City Plan Commission at its December 16, 1987 regular monthly meeting, reviewed and evaluated the subject referral from your Committee on the proposed abandonment of Revere Place.

The petitioner is St. Sahag and St. Mesrob Armenian Apostolic Church represented by Attorney Arthur A. Thovmasian, Jr., of 600 Reservoir Ave., Cranston, RI. The petitioner owns all abutting Lots 691, 689, 688, 687, 699, 336, 639, 340, 698 and 692 on Assessor's Plat 68.

A field inspection revealed that Revere Place is a former paved right-of-way fenced off from Orms St. by a chain link fence and not used for any purpose for many years. All surrounding lots are vacant.

The petitioner is planning to build a community center on the grounds owned by St. Sahag and St. Mesrob Armenian Apostolic Church and the proposed abandonment is necessary to facilitate construction of aforesaid facility.

The Commission voted to advise the Committee on Public Works that no objection is offered to the proposed abandonment.



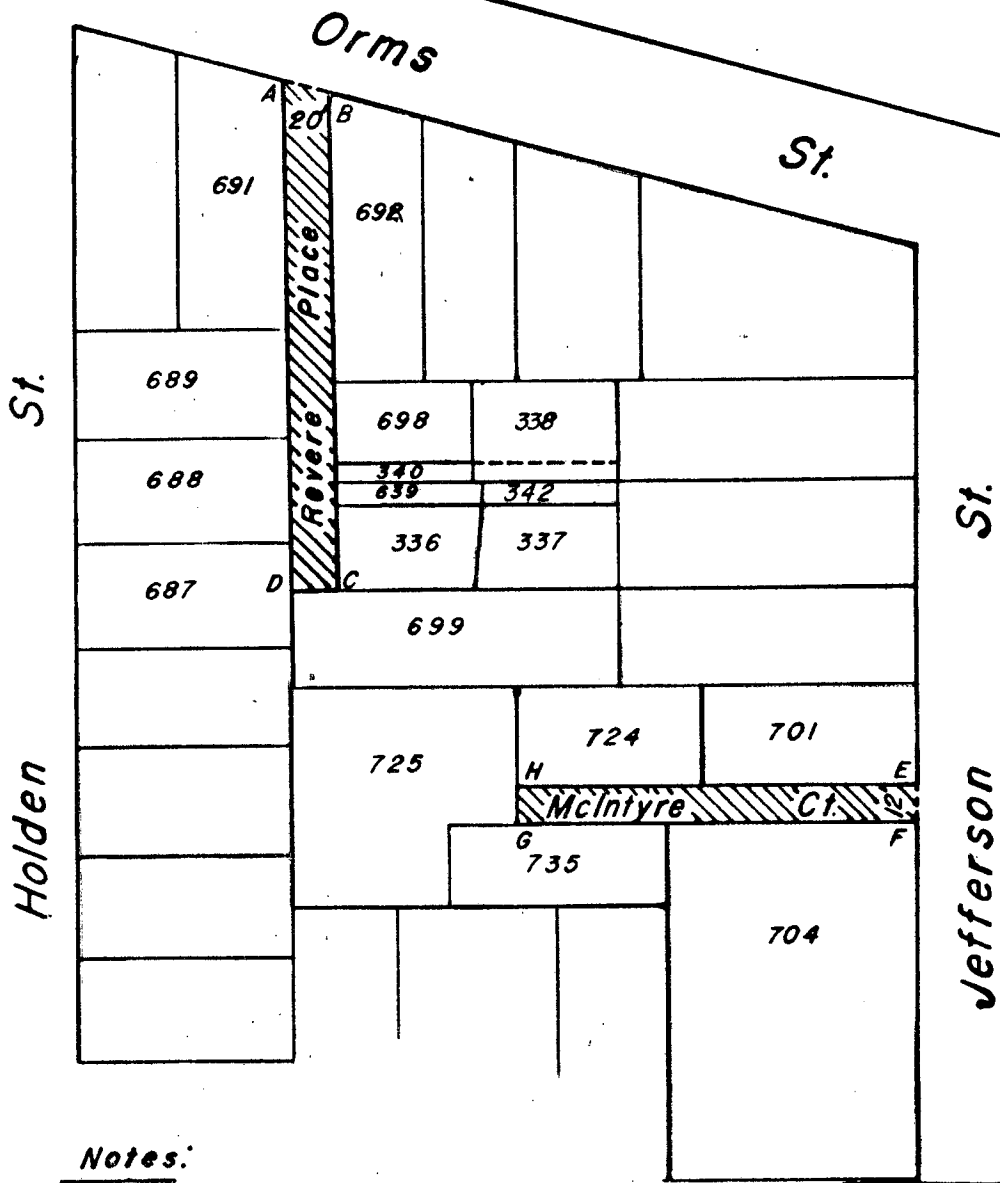


Reference is made to your letter of January 11, 1989 regarding the proposed abandonment of McIntyre Court and Revere Place.
