
I am in receipt of Resolution #1172 approved December 14, 1979. As you know, The Narragansett Electric Company is anxious to comply with the resolutions of the City Council.

In the Resolution it states "That all public utility companies and the Public Utility Commission survey all installations that are thirty-five years or older, both above and below the streets, sidewalks and other areas that may cause danger to the public safety and to bring a long range program for repair and replacement of rotten, worn-out or leaking wire, water and gas lines".

We do not believe any of our facilities in the public way cause danger to the public safety. Further, inspection of facilities below the streets and sidewalks is virtually impossible without removing the streets and sidewalks. Again, electrical cables buried in these areas do not pose safety hazards to the public.
