Be it ordained by the City of Providence:

SECTION 1. Section 17-59 of Article III of the Code of Ordinances is hereby amended by adding sub-section (c), which shall read as follows:

"(c) Supervisory personnel. Any permanent supervisory non-union personnel shall not be entitled to overtime payments without the approval of the Mayor, the Finance Director and the Committee on Finance of the City Council."

SECTION 2. This Ordinance shall take effect upon its Passage.
