LOTS 197, 373, 372 AND 345 ON A.P. 25 AT 299-311 WESTMINSTER
STREET.

Approved September 13, 1993

Be it ordained by the City of Providence:

1. That Chapter 1977-5 of the Ordinance of the City of Providence, approved February 14, 1977 and entitled, "An Ordinance Approving and Adopting the Official Redevelopment Plan for Downtown Providence Renewal" as amended by Chapters 1978-44, 1981-26, 1981-50, 1983-7 and 1983-14 of the Ordinance of the City of Providence, approved November 24, 1978, May 21, 1981, October 23, 1981, February 18, 1983 and April 22, 1983 respectfully, be and the same is hereby further amended as follows:
 - A. In paragraph 6 entitled "Duration and Effective Date of Regulations and Controls" of Section G entitled "Other Provisions Necessary to Meet Local Objectives" on Pages 22 and 23 of the Official Redevelopment Plan which is part of the aforementioned Ordinance, add the following paragraph after the last paragraph.

"After the date of approval of this Redevelopment Plan each and all plan amendments of this Redevelopment Plan relative to all conditions, restrictions and covenants running with the land shall be in full force and effect for a period of forty (40) years commencing on the date of each of its adoption by the City Council".
 - B. The following maps of the aforementioned Official Redevelopment Plan, which is part of the aforementioned Ordinance, hereinafter identified are deleted:

- 2. That said Chapter 1977-5 of the Ordinance of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other aspects.
- 3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy therefore to the Providence Redevelopment Agency.

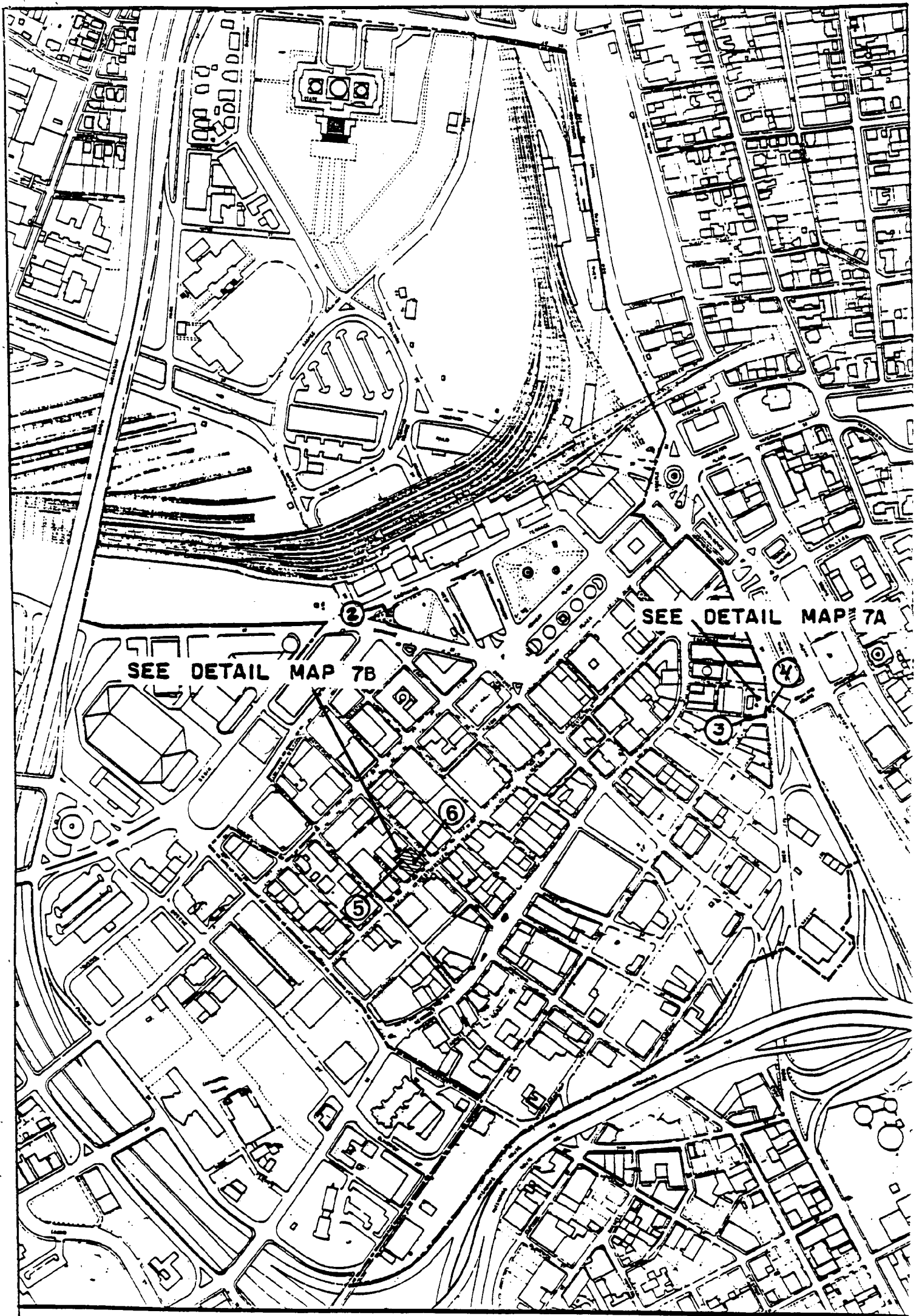

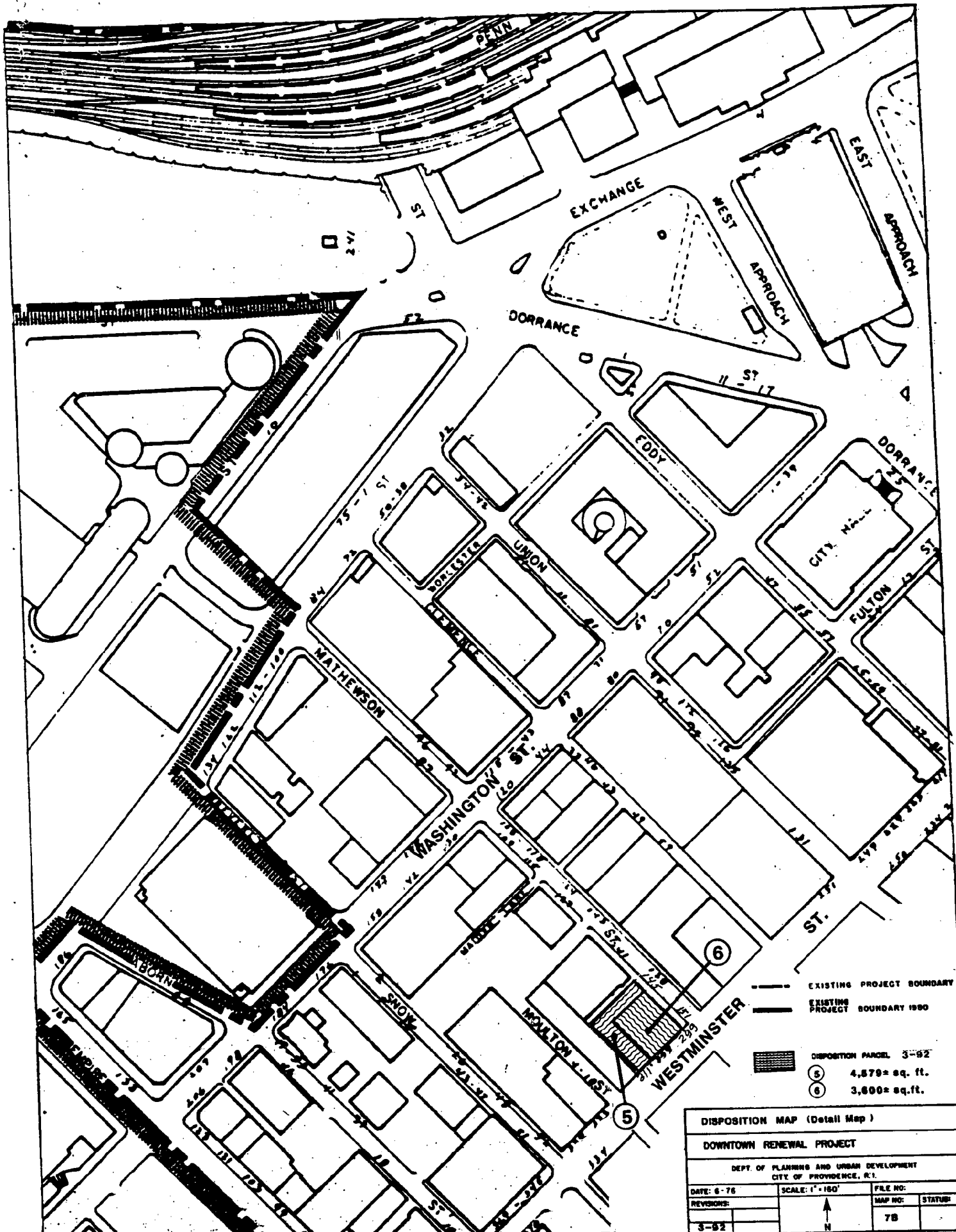

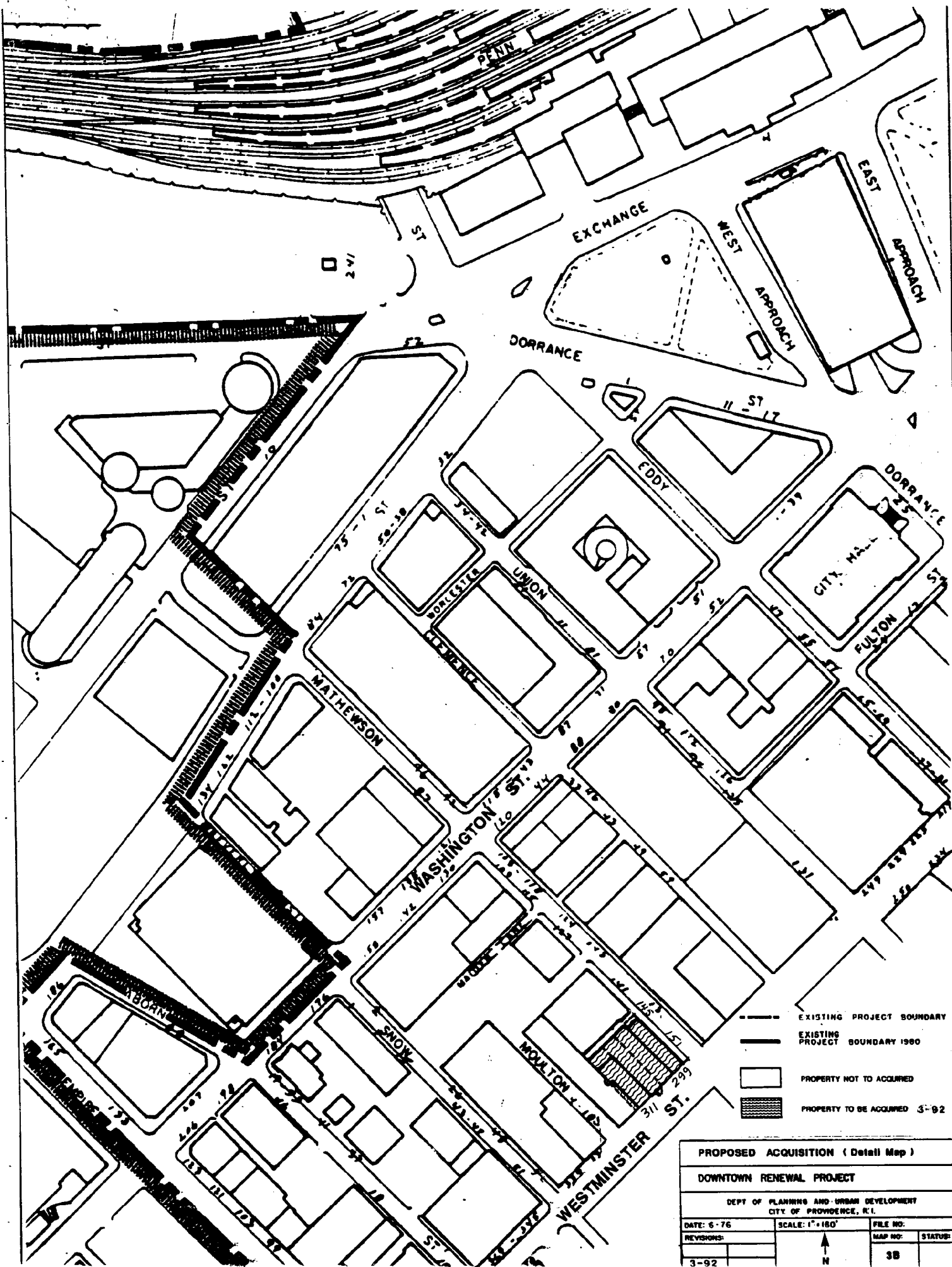

Dear Mr. Clement:

Enclosed is an original and twenty (20) copies of an Ordinance in Amendment to the Downtown Providence Official Redevelopment Plan.

The purpose of this Ordinance is to amend the redevelopment plan for the acquisition of four (4) contiguous lots, Lots 197, 373, 372 and 345 on Assessor's Plat 25 at 299 to 311 Westminster Street and 145 Mathewson Street. Upon acquisition of the four (4) existing buildings (one badly damaged by fire) will be demolished to provide a development site which will be subdivided into two parcels. One 60' x 60' parcel located directly across from Grace Church at the corner of Westminster and Mathewson Streets will be developed for a public park. The other "L" shaped parcel will be developed for two (2) "liner" buildings each flanking one interior side of the park.

This proposal as described above is part of the Downtown Revitalization Plan which is the result of "Charrette" planning session in November 1991 by a group of city officials, city planners, architects, educators, business leaders and other professionals.



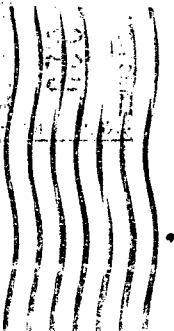
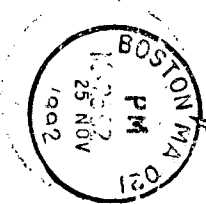

1993 Fleet Contributions to Rhode Island

Fleet Financial Group and its local subsidiary, Fleet Bank-RI, contributed approximately \$865,000 to Rhode Island nonprofit organizations in the first half of 1993. Contributions are made through the corporation's charitable giving program, administered by the Fleet Charitable Trust. Fleet, by focusing charitable giving towards the advancement of youth and economic development, believes that it is contributing to a healthier future for our community.

In 1992, the Trust made its largest gift ever when \$1 million was pledged to the children of Rhode Island. This contribution of \$500,000, payable over five years, for the New Children's Hospital and \$500,000, also payable over five years, to the Brown University School of Medicine, will provide state-of-the-art emergency treatment to as many as 30,000 children annually, and will facilitate advanced neonatal and pediatric research.

Major contributions from the Fleet Charitable Trust in the first half of 1993 include:

Bryant College: contribution in support of the international trade component of Bryant College's Center for International Business and Economic Development (CIBED).

Catholic Charities: contribution to assist in providing many valuable services to children, parents, adults, and the elderly in need throughout the region.

Additionally, each year the Fleet Charitable Trust provides scholarship funds for up to four minority students attending college. Students must be nominated by their high school guidance counselors, and if chosen for the program, they are offered part-time employment at Fleet Bank-RI during summer recess.

The Trust also provides, on an annual basis, \$3,000 grants to independent secondary schools in Rhode Island to be used as scholarship funds for minority students. In 1993, 13 schools participated in this program.
