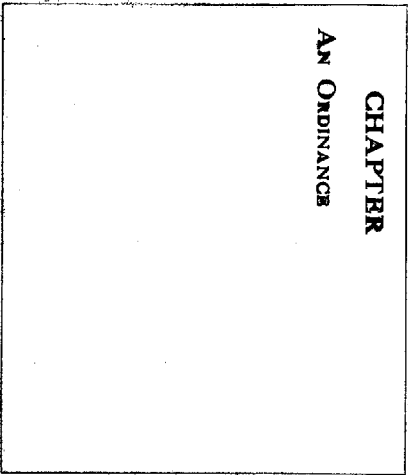

Section 4. This Ordinance Amendment shall take effect upon passage.

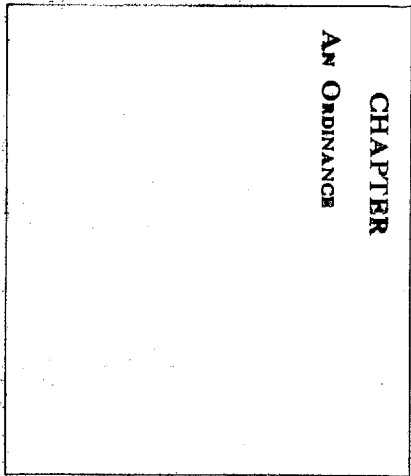
