

I CAME BEFORE THIS HONORABLE BODY JUST TWO YEARS AGO AND PLEDGED THE RESOURCES OF MY ADMINISTRATION TO TRANSFORMING IDEAS INTO ACTION....POLITICAL POWER INTO POLICY....THE STATUS QUO INTO PROGRESS. I SAID AT THAT TIME THAT WE HAD A GREAT OPPORTUNITYAN OPPORTUNITY WHICH MIGHT NOT COME AGAIN....AN OPPORTUNITY TO DEDICATE OURSELVES TO A GREAT BEGINNING....A BEGINNING WHICH WOULD START PROVIDENCE ON THE ROAD TO SELF RENEWAL.

NOW, TWO YEARS LATER, LET US LOOK BACK FOR A MOMENT AND REVIEW OUR PROGRESS. CERTAINLY THERE EXISTS A SPIRIT OF PROGRESS.... A SENSE OF ENERGY....A FEELING OF NEW LIFE.

THE PROGRESS OF PHYSICAL IMPROVEMENT HAS BEEN THE GREATEST IN THE HISTORY OF THIS CITY. THE PACE OF NEW CONSTRUCTION IS UNPRECEDENTED....NEW OFFICE BUILDINGS....NEW MODERN APARTMENT STRUCTURES....A NEW EDUCATION CENTER....ENLARGED TRANSPORTATION FACILITIES....AND NEW AND EXPANDING BUSINESSES IN OUR INDUSTRIAL PARKS....ALL ADD TO OUR FEELING OF ACCOMPLISHMENT.

FURTHERMORE, PROGRESS CAN BE REPORTED IN NEIGHBORHOOD

RENEWAL. ACTUAL PLANNING IS UNDERWAY TO REHABILITATE THE MOUNT HOPE AREA....PLANNING MONEY IS NOW AVAILABLE FOR THE WEST BROADWAY PROJECT AREA....EXECUTION WILL BEGIN IN THE EAST SIDE RENEWAL AREA IN THE NEXT FEW MONTHS. WHILE RELYING HEAVILY ON FEDERAL ASSISTANCE IN COSTLY NEIGHBORHOOD REHABILITATION ACTIVITY THE CITY ITSELF HAS MOVED AHEAD WITH ITS OWN RESOURCES TO IMPROVE AND SUSTAIN CONDITIONS....RECREATIONAL IMPROVEMENTS, DEMOLITION OF BLIGHTED STRUCTURES, INCREASED HOUSING INSPECTION, AND NEIGHBORHOOD CLEANUP DRIVES ALL HAVE BEEN EFFECTIVE INCENTIVES FOR INDIVIDUAL AND NEIGHBORHOOD RENEWAL.

NEW SOCIAL PROGRAMS HAVE GIVEN HOPE AND OPPORTUNITY TO MANY. THE OFFICE OF ECONOMIC OPPORTUNITY PROGRAMS IN TWO SHORT YEARS HAVE SHOWN US A NEW CONCEPT OF COMMUNITY ACTION THAT HAS ASSISTED DISADVANTAGED CHILDREN, YOUTH AND PARENTS, ALIKE. THESE PROGRAMS MAY NOT BE THE CURE ALL BUT THEY ARE A GOOD BEGINNING IN A CRUCIAL AREA.

OUR RECENTLY DEDICATED MULTI-PURPOSE AGING CENTER WAS

ENTHUSIASTICALLY RECEIVED BY MANY OF OUR ELDER CITIZENS. THE FOOD STAMP PROGRAM IS OF DIRECT ASSISTANCE TO THOUSANDS OF FAMILIES IN THE COMMUNITY.

A POSITIVE AND OUTRIGHT ATTACK ON THE PROBLEM OF WATER RESOURCES....SUPPORTED BY A SEVEN AND A QUARTER MILLION DOLLAR MATCHING GRANT FROM THE FEDERAL GOVERNMENT....HAS ENABLED PROVIDENCE TO CONTINUE TO MEET THE NEEDS OF ITS OWN CITIZENS, AND THOSE OF SISTER COMMUNITIES.

ONCE AGAIN WE USHER IN A NEW ERA IN THE CITY OF PROVIDENCEONCE AGAIN WE MAKE HISTORY AS THE FIRST MAYOR AND THE FIRST COUNCIL TO BE INVESTED WITH THE CONTROL OF GOVERNMENT FOR A FOUR-YEAR TERM OF OFFICE. AN INAUGURAL MESSAGE FOR SUCH A PERIOD DOES NOT PERMIT THE DETAILING OF PROPOSED PROGRAMS, BUT DOES PRESENT THE OPPORTUNITY OF STATING OR RESTATING THE GOALS WE SEEK. THE PROGRAMS WE STRIVE TO COMPLETE AND THE PROPOSALS WHICH WE DEVELOP DURING THIS PERIOD MUST THEN BE GEARED TO CLEARLY DEFINED GOALS.

OUR PRIMARY GOAL IS THE VERY GOAL OF SOCIETY. IT IS

NOT SOLELY TO PROMOTE ECONOMY....TO FOSTER EDUCATION OR TECHNOLOGY
....TO PROVIDE HOUSING OR TO PROMOTE LAW AND EFFICIENT GOVERNMENT
....AS IMPORTANT AS THESE MAY BE. THE PURPOSE OF OUR PROGRAMS....
THE DESIGN OF OUR ADMINISTRATION....THE VERY PURPOSE FOR PRESERVA-
TION OF THE CITY....IS FOR PEOPLE. THUS, OUR PRIMARY GOAL IS TO
RELEASE THE HUMAN POTENTIAL OF EVERY PERSON REGARDLESS OF RACE OR
CREED. AS ONE MAN SO WELL STATED, "EVERY MAN HIS CHANCE TO DO WITH
HIS LIFE WHAT HE WILL".

OUR OTHER GOALS OF ECONOMIC VITALITY, EDUCATIONAL
VITALITY, AND CIVIC VITALITY ARE ALL REALLY A PART....A PIECE....
OF THE COMMON GOAL.

WHILE WE HAVE MADE PROGRESS, AND MAY FEEL A SENSE OF
SATISFACTION, LET US HEED THE WORDS OF OUR PRESIDENT - "WE SHOULD
NOT MAKE OUR PROGRESS A SAFE HARBOR, A RESTING PLACE, A FINAL
OBJECTIVE, A FINISHED WORK. IT SHOULD BE A CHALLENGE CONSTANTLY
RENEWED".

TODAY WE REDEDICATE OUR EFFORTS TO MAKE PROVIDENCE A

CITY DESIGNED FOR PEOPLE.

PHYSICALLY WE WILL CONTINUE OUR PROGRAM TO COMPLETE THE URBAN RENEWAL ALREADY STARTED. . . . LIPPITT HILL, WEYBOSSET HILL, CENTRAL-CLASSICAL. WE WILL FILL HUNTINGTON AVENUE INDUSTRIAL PARK EVEN IF THIS REQUIRES ADDITIONAL AMENDMENTS TO THE ORIGINALLY ESTABLISHED GUIDELINES. WE WILL BEGIN EXECUTION OF THE LONG-AWAITED EAST SIDE RENEWAL PROJECT. WE WILL COMPLETE THE PLANNING AND COMMENCE EXECUTION OF THE MOUNT HOPE REHABILITATION PROJECT AND THE WEST BROADWAY PROJECT WHICH OPENS THE DOOR TO THE MASSIVE GENERAL NEIGHBORHOOD RENEWAL PROGRAM. WE WILL COMPLETE, SUBMIT AND PURSUE FUNDING FOR THE MUCH DISCUSSED RAILROAD PROJECT.

ALL THIS WORK WILL REQUIRE TREMENDOUS EFFORT, ENERGY AND TALENT. IT WILL REQUIRE UNPRECEDENTED COORDINATION AND COOPERATION BETWEEN VARIOUS CITY AGENCIES AND STAFFS. THE CREATIVE ABILITY REQUIRED TO PLAN AND CARRY THROUGH SUCH PROJECTS CANNOT BE SECURED WITHOUT REASONABLE COMPENSATION. I WILL SUBMIT TO YOU TODAY A PROPOSAL WHICH AFTER CAREFUL CONSIDERATION I FEEL WILL MEET THE

CHALLENGE....A SOLUTION WHICH WILL HARNESS THE ENERGY AND ECONOMICALLY PERMIT THE CREATIVITY NECESSARY TO CARRY OUT THESE EXPANDED RESPONSIBILITIES.

WE MUST ALSO ASSESS OUR EFFORTS IN THE WAR AGAINST POVERTY. HERE AGAIN, I WILL INSIST UPON AN AUDIT SO THAT WE MIGHT DETERMINE WHETHER EXISTING PROGRAMS ARE HAVING A BENEFICIAL EFFECT UPON THE SOCIAL PROBLEMS OF OUR PEOPLE. FUTURE EFFORTS AND EXPENDITURES WILL BE MEASURED AGAINST BENEFITS GENERATED.

WE CANNOT STOP WITH REORGANIZATION IN THE PLANNING AND RENEWAL SPHERE OF ACTIVITY. OUR CHARTER IS TWENTY-SIX YEARS OLD. SINCE ITS ACCEPTANCE MANY NEW AREAS OF MUNICIPAL ACTIVITY HAVE ARISEN. AGENCIES CREATED TO MEET THESE NEW AREAS OF ACTIVITY WERE SOMETIMES ATTACHED TO EXISTING DEPARTMENTS FOR REASONS WHICH TODAY DO NOT FIT IN WITH MODERN MUNICIPAL THINKING. AT THE SAME TIME, NEW ADJUSTMENTS OF CITY-STATE RELATIONS HAVE LEFT SEGMENTS OF OLD DEPARTMENTS WITHOUT FIRM ASSOCIATION WITH THE PRESENT STRUCTURE OF CITY GOVERNMENT. AGAIN, IT MAY BE BEST TO INCORPORATE CERTAIN

SMALLER OPERATIONS INTO LARGER DEPARTMENTS, THUS PROVIDING BETTER ORGANIZATION AND A CLEARER LINE OF COMMAND. OUR ADMINISTRATIVE FRAMEWORK MUST BE STRUCTURED SO WE CAN MOVE MORE SWIFTLY TOWARD OUR GOALS.

THE LEGISLATURE HAS GRANTED US THE POWER TO REORGANIZE OUR MUNICIPAL DEPARTMENTS WHEN IT IS IN THE BEST INTERESTS OF THE COMMUNITY. I BELIEVE WE SHOULD TAKE FULL ADVANTAGE OF THIS PERMISSIVE LEGISLATION WHENEVER IT CAN BE SHOWN MUNICIPAL GOVERNMENT CAN OPERATE MORE EFFICIENTLY AND ECONOMICALLY THROUGH SUCH ORGANIZATIONAL ADJUSTMENT.

I CANNOT EMPHASIZE TOO STRONGLY THE CITY'S GROWING NEED FOR TECHNICAL TALENT IF WE ARE TO HAVE MODERN, EFFICIENT AND EFFECTIVE MUNICIPAL OPERATIONS. NOR CAN I OVERSTATE THE NEED TO MAKE OUR CITY GOVERNMENT WAGE STRUCTURE COMPETITIVE IF WE ARE TO SECURE THE NEEDED TALENT.

I PROPOSE A REVIEW OF JOB CLASSIFICATIONS AND THE NUMBER OF POSITIONS IN THE CITY SERVICE. FEWER POSITIONS PERMIT A BETTER

SALARY STRUCTURE WITHOUT INCREASING THE IMPACT ON THE TAX-PAYING PUBLIC.

THIS FISCAL YEAR THE PROVIDENCE SCHOOL SYSTEM RECEIVED ITS HIGHEST APPROPRIATION IN THE CITY'S HISTORY. THE CITY'S ADDITIONAL APPROPRIATION, ADOPTED BY THIS HONORABLE COUNCIL, WAS ALMOST TWICE THE AMOUNT OF ADDITIONAL STATE AID. OUR APPROPRIATION CAME FROM SURPLUS. THE FAILURE OF THE STATE OF RHODE ISLAND TO RAISE THE MINIMUM GRANT TO EDUCATION AND TO CORRECT INEQUITIES IN THE PRESENT FORMULA AND TO RECOGNIZE THE SINGULAR EDUCATIONAL PROBLEMS OF ITS CAPITOL CITY IN THE COMING LEGISLATURE WILL HAVE A MOST SERIOUS EFFECT ON OUR LOCAL TAX RATE. LAST YEAR'S ORIGINAL REQUEST FROM THE SCHOOL DEPARTMENT WAS EQUAL TO AN INCREASE OF ALMOST FIVE DOLLARS IN THE TAX RATE. WE EARNESTLY REQUEST ASSISTANCE NOW.

FURTHERMORE, WHILE THE CITY ITSELF IS WATCHING PENNIES IN ORDER TO SAVE DOLLARS AND WHILE CITY EMPLOYEES ARE BEING ASKED BY

MUNICIPAL LEADERS TO ASSIST US IN "RIDING THE STORM" SO MUST THE

SCHOOL DEPARTMENT JUSTIFY ITS EXPENDITURES, WATCH ITS PENNIES AND

SO MUST THE SCHOOL COMMITTEE STAND UP TO DEMANDS WHICH WOULD PLACE

ITS EMPLOYEES IN A MUCH HIGHER PAY SCALE THAN OTHER CITY EMPLOYEES.

THE SCHOOL ADMINISTRATION HAS AN OBLIGATION TO EFFECT ALL MEASURES

OF ECONOMY EVEN THOUGH THESE MAY BE NO MORE POPULAR THAN A TAX

INCREASE. MAY I SUGGEST THE SCHOOL DEPARTMENT CONSIDER A LINE ITEM

BUDGET SIMILAR TO THE ONE WHICH CONTROLS OTHER CITY EXPENDITURES.

SHOULD THE PRESENT INFLATIONARY TREND CONTINUE, IT IS

REASONABLE TO ASSUME THAT THE COST OF PROVIDING EFFECTIVE PUBLIC

SAFETY IN THE CITY IS GOING TO INCREASE. THE PROBLEM OF RAISING REVENUE

TO MEET THE INCREASED COST OF SUCH PROTECTION COMPELS US TO CONSIDER

MEASURES FOR THE IMPROVEMENT IN THE SERVICE THAT WILL JUSTIFY THE

INCREASED EXPENDITURE.

THE PRESERVATION OF ORDER IN TODAY'S SOCIETY IS MUCH DIFFERENT

THAN THAT OF A DECADE OR TWO AGO.

THE SOCIAL UNREST, AND THE CONSTITUTIONAL GUARANTEES RENDER-

ING OBSOLETE MANY OF THE TRADITIONAL POLICE METHODS FOR ACCUMULATING

AND PRESENTING EVIDENCE TO CONVICT OR INDICT FOR CRIME, NECESSARILY REQUIRE HIGHLY IMPROVED AND SKILLED POLICE WORK.

IN RETURN FOR GREATER COMPENSATION, WE CAN JUSTIFIABLY ASK FOR THE QUALIFICATIONS THAT ARE NECESSARY TO MEET TODAY'S SOCIAL PROBLEMS AND POLICE PERFORMANCE. MEMBERS OF THE DEPARTMENT MUST BE INSTRUCTED IN MODERN POLICE PROCEDURES AND BE CAPABLE OF THE INTELLECTUAL DISCIPLINE REQUIRED FOR A MODERN DAY POLICEMAN AND OFFICER.

I WILL PROPOSE A PROGRAM TO THIS COUNCIL WHICH WILL ALLOW THE CREATION OF A SPECIAL FORCE WITHIN THE DEPARTMENT OF PUBLIC SAFETY. APPLICANTS WILL BE SELECTED BY A PANEL COMMANDING PUBLIC CONFIDENCE. THESE INDIVIDUALS WILL FOLLOW A COURSE OF STUDY DEVELOPED BY SOCIOLOGISTS, CRIMINOLOGISTS AND MEMBERS OF THE JUDICIARY. WHEN COMPLETED, THEY WILL BE SPECIALISTS WHO WILL HAVE UNDERGONE A VIGOROUS COURSE OF INTELLECTUAL AND PHYSICAL DISCIPLINE AND THEY WILL BE ENTITLED TO HIGHER RENUMERATION. EVERY MAN ON THE DEPARTMENT WILL BE GIVEN THE OPPORTUNITY TO PARTICIPATE.

FINALLY, I WOULD LIKE TO REPEAT MY CONCERN FOR THE FISCAL

FUTURE OF OUR CITY. DURING THE LAST TWO YEARS IMAGINATIVE ACTION AND YOUR COOPERATION HAVE ALLOWED THIS ADMINISTRATION TO INCREASE SCHOOL APPROPRIATIONS, PROVIDE BLUE CROSS AND A GENERAL PAY RAISE, GRANT ADDITIONAL FUNDS FOR THE SUPPORT OF LIBRARIES AND MAINTAIN A HIGH LEVEL OF MUNICIPAL SERVICE WITHOUT A TAX INCREASE. I PLEDGE CONTINUED EFFORT TO ECONOMIZE AND TO EXPLORE MEANS OF MAKING BETTER USE OF TAX DOLLARS.

HOWEVER, AT A TIME WHEN WE SPEAK OF NEW SCHOOLS, NEW RECREATIONAL FACILITIES, URBAN RENEWAL, PAY RAISES AND A HOST OF OTHER MUNICIPAL SERVICES, IT SHOULD BE ABUNDANTLY CLEAR TO ALL CONCERNED THAT ADDITIONAL REVENUE WILL BE NECESSARY IN THE NEAR FUTURE. I DO NOT MEAN THAT I WILL PROPOSE A TAX INCREASE, ALTHOUGH I DO NOT PRECLUDE THE POSSIBILITY. IN FACT, I AM MORE CONCERNED WITH THE GROWING NUMBER OF EXEMPTIONS AND SPECIAL PRIVILEGES GIVEN TO THE ELEEMOSYNARY INSTITUTIONS OF THIS CITY.

IF THE PRESENT TREND CONTINUES, IT MAY BECOME FISCALLY IMPOSSIBLE FOR THE CITY TO OPERATE WITHIN THE LIMITATIONS OF THE PRESENT TAX STRUCTURE. I HAVE IMPLEMENTED A NUMBER OF EFFICIENCIES AND ECONOMIES

OVER THE COURSE OF THE PAST TWO YEARS, BUT THEY HAVE NOT YIELDED SUFFICIENT REVENUES TO OFFSET THE LOSSES OCCASIONED BY THE TAX EXEMPT INSTITUTIONS, WHOSE DAILY GROWTH IS COSTING THE CITY MILLIONS OF DOLLARS FOR MUNICIPAL SERVICES. WE MUST COME TO GRIPS WITH THIS PROBLEM IMMEDIATELY OR WE MAY BE COMPELLED TO LOOK TO NEW REVENUE IF WE ARE TO MEET THE NEEDS OF THE PROVIDENCE WE ENVISION.

IN A SENSE THE MESSAGE WHICH I AM DELIVERING HERE TODAY IS A BLUEPRINT FOR ACTION. IT IS A CHALLENGE, TO THOSE IN BOTH THE PUBLIC AND PRIVATE SECTORS OF OUR ECONOMY TO JOIN TOGETHER IN THE TASK WHICH HAS BEEN SET OUT. FOR TOO LONG NOW THE PEOPLE OF THIS CITY HAVE HEARD OF OUR PLANS AND OF THE PROSPECTS FOR MAKING PROVIDENCE AN ATTRACTIVE URBAN CENTER. THEY HAVE BEEN FILLED WITH IDEAS AND THE DESIGNS OF WHAT A NEW PROVIDENCE CAN AND SHOULD LOOK LIKE. THEY HAVE BEEN INNOCULATED WITH THE SERUM OF THIS NEW CITY CONCEPT, BUT THEY HAVE NOT YET SEEN THE OLD VIRUS DISSIPATED.

I AM NOT HERE TO PROMISE YOU PLANS. I AM HERE TODAY TO GIVE MY SOLEMN PLEDGE TO TRANSFORM THE POVERTY, IGNORANCE AND

SUB-STANDARD HOUSING OF THIS CITY INTO A VIABLE AND PRODUCTIVE
COMMUNITY. THE ENTIRE ENERGY OF THIS ADMINISTRATION WILL BE
DEVOTED TO A PROGRAM OF ACTION WHICH WILL GIVE PROVIDENCE A
TRULY NEW PROFILE.

I AM HERE, TODAY, TO ASK YOUR ACTIVE INTEREST, PARTICIPATION
AND COMMITMENT IN OUR EFFORTS TO RENEW OUR CITY AND ITS PEOPLE.


