Approved August 15, 1975

RESOLVED, DECREED, AND ORDERED:

That the following named highway shown as cross-hatched area on the accompanying Plan entitled "Providence, R. I., P. W. Dept. - Engineering Office, Street Line Section Plan No. 063927, Date: June 11, 1975,

viz:

CARVEL STREET, between Brush Hill Road and Ortoleva Drive, having ceased to be useful to the public and the same is abandoned as a public highway and the damage to the abutters is appraised at nothing and so awarded,<sup>A</sup> and it is further

ORDERED, that the Director of Public Works, be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words "Not a Public Highway", and it is further

ORDERED, that after the entry of this order or decree, the City Clerk shall cause a notice, thereof, to be published in a newspaper published in the County of Providence at least once a week for three successive weeks, and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within this State.

SUBJECT: Referral No. 1929 - ABANDONMENT CARVEL ST.

Gentlemen:

This petition from the Committee on Public Works of the Providence City Council presents for study a petition by the owners of adjacent property for the abandonment of a platted street described as Carvel St. between Brush Hill Road and Ortoleva Drive.

On a tour of inspection it was determined that the location platted as Carvel St. exists only as a curb cut off Ortoleva Drive opposite No. 165 and a short dead end unpaved path in a westerly direction from Ortoleva Drive. Brush Hill Road is not a passable thoroughfare at this location but exists only on "paper". There is a 60 percent grade rising from Carvel St. from a point approximately 80 ft. west of Ortoleva Drive to the platted location of Brush Hill Road.

In view of the extreme difference in elevation between the eastern and westerly ends of Carvel St. and, additionally, the questionable value of a connector street at this location, no objection is offered, from a planning standpoint, to the proposed abandonment.



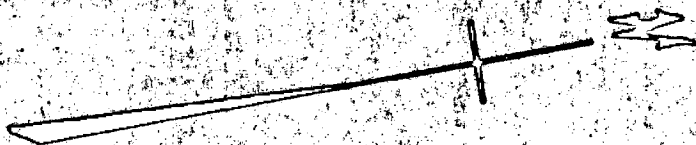
A review of our distribution system indicates that we do not have any facilities in that section, therefore, have no objection to the petition.

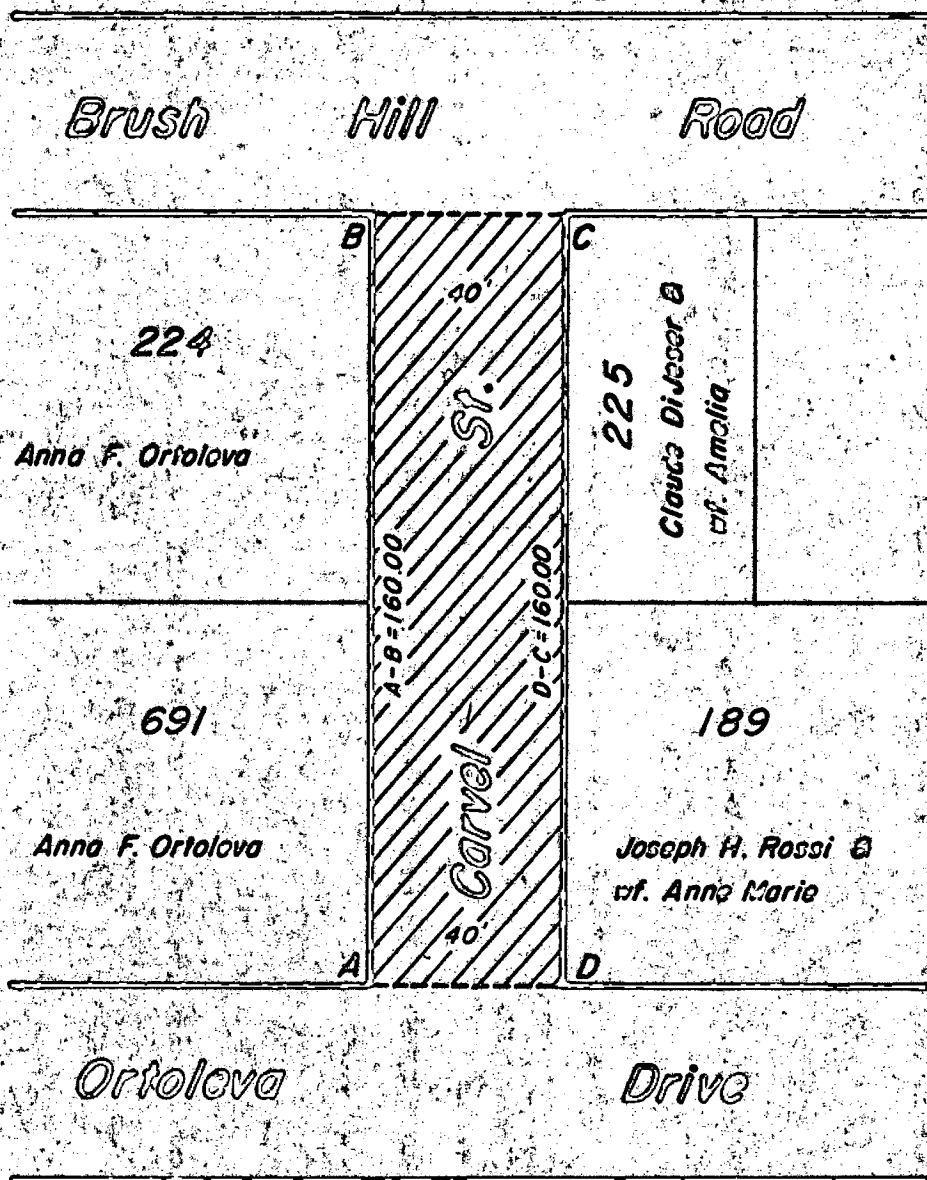
