"I'm so proud tonight to be able to
honor with my colleagues the Hope High
School boys soccer team. Many of you
have known me from the past between
the years of 1984 and 1994. I actually
worked at Hope High School before I
became a City Councilperson and my
heart and soul has always been with
Hope High School because they were the
school that gave me an opportunity to do
the things that I love to do before I
became a City Councilperson. We're here
tonight because this is really a crowning
achievement for the City of Providence
and the Providence School Department.
The reason being is all the time in the
paper we hear how we want our
students, and our student athletes, to
achieve to the highest level. We talk
about comparing Providence Schools to
schools in Barrington and schools in

East Greenwich and schools all over the
State of Rhode Island. What these young
men did today, and I think as you see
sitting out there, they are what we look
for in student athletes. A number of
them have ties on, they're sitting there
very proud of what we're going to bestow
upon them tonight and they achieved it
at the highest level. People who don't
understand sports, there is four
different State Champions. There is a
Class D, there is a Class C, there is a
Class B. These young men are Class A
State Champions. The real State
Champions in soccer. When you, as an
athletic team, have accepted to play in
Class A, you have accepted to play in the
highest level of competition that the
State of Rhode Island provides. You can
choose to be in B, C or D, but when you
choose to be in A, you're choosing to
compete against all the high schools
that have chosen to be at that highest
level. That's what we preach to our
students all the time. That they need to
be at that highest level both

academically and athletically and these young men achieve that in the athletic field and I'm sure Dr. Montague would say that they've also achieved that in the classroom. Just to give you a little summary. During the regular season they had 10 wins, 4 losses and 4 ties. Every member of this team has contributed to the winning season. They have been identified by many spectators as a team that exhibits outstanding sportsmanship. The coaching staff is excellent and has made many offensive and defensive changes to meet the challenge of each opponent. The team ended LaSalle's three year undefeated record this year by defeating them 1 to 0 and LaSalle was a nationally ranked team throughout those three years also. The Hope boy's soccer team lost to Central Falls and tied Barrington and Mount Hope during the regular season but came back to defeat all three teams during the playoffs. They were ranked as the fifth seed entering the State playoffs. Their playoff record, they first defeated Woonsocket 1 to 0. They defeated Central Falls 1 to 0 when Winston Smith scored the winning goal. They defeated Barrington 3 to 2 when Matthew Wenton and Chris Tucker each scored one goal each to help Hope come back from a 2 to 0 deficit and then they played two overtime periods with no score and then won in a shoot out 13 to 12. Then in the championship game at Rhode Island College where I now coach they defeated Mount Hope 2 to 1. Chris Tucker scored the first goal and Winston Smith scored the second goal with one minute remaining in the game and then at that moment they were crowned State Champions in soccer for the State of Rhode Island.
