Chapter 1788 of the Ordinances of the City of Providence, as approved September 26, 1966, and entitled: "An Ordinance Making Appropriation of \$47,405,335.25 for the Support of the City Government for the Fiscal Year Ending September 30, 1967", as amended, is hereby further amended by appropriating the sum of Sixteen Thousand Five Hundred (\$16,500) Dollars to the BOARD OF CANVASSERS, as follows: ITEM 0 - \$12,175; and ITEM 1 - \$4,325.

SECTION 2. The said sum of Sixteen Thousand Five Hundred (\$16,500) Dollars as hereby appropriated shall be charged to the General Fund from Funds Not Otherwise Appropriated.
