PHYSICAL THERAPIST II

CLASS TITLE: PHYSICAL THERAPIST II

CLASS DEFINITION: Performs highly responsible work involving professional work as a physical therapist, and related work as required.

DISTINGUISHING FEATURES OF WORK: Work involves responsibility for immediate supervision of physical therapist services at the Charles V. Chapin Hospital.

EXAMPLES OF WORK: (Note: The following examples of work are only illustrative of the kind of work to be performed by persons of this class and are not intended to be all-inclusive or exclusive.) Duties shall include all phases of Physical Medicine, for examples: (1) Hydrotherapy, (2) Electrotherapy, (3) Mechanotherapy, (4) Light therapy, (5) General application of heat, (6) Local application of heat, (7) Local application of cold. The physical therapist shall be responsible for charting of all treatments, to conform with recommendations of the American Congress of Physical Therapy. Keeps records and makes reports. Responsible for the care and upkeep of equipment.

NECESSARY KNOWLEDGES, SKILLS AND ABILITIES: Thorough knowledge of modern approved physical therapy methods and techniques which are utilized in the care and treatment of afflicted or disabled persons.

QUALIFICATIONS REQUIRED FOR APPOINTMENT: Extensive physical therapy experience in a hospital, or its equivalent. Graduation from an approved school of Physical Medicine, preferably a graduate nurse.
