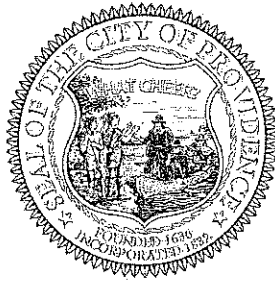

COUNCILWOMAN RYAN.**


**COUNCILMAN PRINCIPE Moves Passage of the Ordinance the First Time, As Amended,
