No. 487 AN ORDINANCE AMENDING CHAPTER 17, SECTION 85 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE RELATIVE TO PAYMENT FOR COST OF HOSPITALIZATION, RELATED BENEFITS.

Approved November 9, 1971

Be it ordained by the City of Providence:

SECTION 1: Section 17-85, paragraph (a), Code of Ordinances of the City of Providence is hereby amended to read as follows:

"(a)The city treasurer of the city shall make payment to the Hospital Service Corporation of Rhode Island and Rhode Island Medical Society Physicians Service for the full cost of Blue Cross (Comprehensive Plan) and Physicians Service, individual membership, or at the election of any officer or employee of the several departments of the City, to the Rhode Island Group Health Association, a non-profit health care organization at such rates as shall be established from time to time by the Hospital Service Corporation of Rhode Island, and Rhode Island Medical Society Physicians Service individual membership, for all officers and employees of the several departments of the City as designated by the Mayor and Finance Director, except officers and employees of the School Department."

SEC. 2. This Ordinance shall take effect upon its passage.

No. 488 AN ORDINANCE IN AMENDMENT OF ARTICLE IV,

ENTITLED "SEWER RENTS", SECTIONS 25-50 and 25-52 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, AS AMENDED AUGUST 30, 1968, AND ADDING SECTION 25-63 TO SAID ARTICLE IV.

Approved November 9, 1971

Be it ordained by the City of Providence:

SECTION 1: Section 25-50 ENTITLED "ANNUAL SEWER RENTAL IMPOSED"

is hereby amended to read as follows:

"There is hereby imposed an annual sewer rental or charge for the use of sewers, sewerage system and sewage treatment works of the city, upon all industrial and commercial plants, facilities and all other users of said sewers or sewerage system, except users using same for the disposal of sewage or other waste matter from any premises or building used exclusively for residential premises and comprising not more than six (6) dwelling units or public schools or tax supported departments of the city, at the rates hereinafter set forth. The charge herein made, except as otherwise hereinafter provided, is assessed upon the recorded owner of the property served and having a connection or connections with said sewers, sewerage system and sewage treatment works; said owner shall and he hereby is deemed to be in control of said connection or connections and the user, either actually or constructively, of said sewers, sewerage system and sewage treatment works. (Ch. 32A, Sec. 1, added by Ord. 1946, ch. 1525, Sec. 1; Ord. 1947, ch. 1649, Sec. 1; Ord. 1949, ch. 226, Sec. 1)"

Section 2: Section 25-52 ENTITLED "AMOUNT OF SEWER RENTAL CHARGE"

is hereby amended to read as follows:

"The sewer rental charge imposed herein shall be based upon the actual registration of the meter at the rate of six cents (\$0.06) per hundred cubic feet of water; provided however, that a minimum charge shall be collected from all owners or users subject to a charge under the provisions of section 25-50, as follows:

ANNUAL MINIMUM CHARGE

"This charge includes the cost of sewer rental for each water service connection at the established rate up to the amount of the minimum charge.

"These charges are according to the size of the meter as follows:

<u>Meter size</u>	<u>Charge</u>
5/8 inch -----	\$ 3.00
3/4 inch -----	3.00
1 inch -----	3.75
1 1/2 inch -----	5.60
2 inch -----	7.50
3 inch -----	12.00

8 inch -----	35.00
10 inch -----	75.00
12 inch -----	112.50

PROPERTY USING CITY WATER

"For a property that uses city water, the sewer rental charge will be based upon the actual registration of each water meter that measures the supply on each service connection. (Ch. 32A, Sec. 2, added by Ord. 1946, ch. 1525, Sec. 2; Ord. 1947, ch. 1649, Sec. 1)"

SECTION 3. Section 25-63 ENTITLED "PERIOD WHEN RENTAL SHALL BECOME EFFECTIVE", is hereby added to Article IV of said Code of Ordinances of the City of Providence:

"The sewer rental or charge for the use of sewers, sewerage system and sewage treatment works of the City of Providence hereby imposed shall become effective on the first day of January, A.D. 1972, at the rates fixed herein."

SECTION 4. This Ordinance shall take effect January 1, 1972.

No. 492 **AN ORDINANCE** IN AMENDMENT OF CHAPTER 1079 OF THE ORDINANCES OF THE CITY OF PROVIDENCE APPROVED DECEMBER 21, 1956 WHICH SAID ORDINANCE IS ENTITLED "BUILDING ORDINANCES OF THE CITY OF PROVIDENCE" TO DELETE THEREFROM A CERTAIN SECTION OF THE EAST SIDE REDEVELOPMENT PROJECT AREA OF THE PROVIDENCE REDEVELOPMENT AGENCY FROM FIRE DISTRICT ONE.

Be it ordained by the City of Providence:

WHEREAS, the City Council of the City of Providence did on the 20th day of December, 1956 adopt Chapter 1079 of the Ordinance of the City of Providence, which said Ordinance was duly approved December 21, 1956 and this said Ordinance is entitled "Building Ordinance of the City of Providence," and

WHEREAS, said Ordinance sub-divides the City of Providence into Fire Districts for the purpose of controlling all use and construction of buildings; and

WHEREAS, the Providence Redevelopment Agency is desirous of deleting a certain section of the East Side Redevelopment Project area from Fire District 1 under Section 301.1 of Chapter 1079 of the Ordinances of the City of Providence entitled "Building Ordinances of City of Providence" approved December 21, 1956.

BE IT ORDAINED BY THE CITY OF PROVIDENCE:

1) That Chapter 1079 of the Ordinances of the City of Providence entitled "Building Ordinance of City of Providence" approved December 21, 1956 be and the same is hereby amended by deleting therefrom in Section 301.1 of the said Ordinance a certain section of the East Side Redevelopment Project area which is described as follows:

Starting at the intersection of the center lines of Captain J. Carlton Davis Boulevard and Hewes Street;

running, southerly along the center line of Captain J. Carlton Davis Boulevard to the intersection of the center lines of Captain J. Carlton Davis Boulevard and North Main Street;

thence, running southerly along the center line of North Main Street to the intersection of the center lines of North Main Street and Canal Street;

thence running Southerly along the center line of Canal Street to the intersection of the center lines of Canal Street and Smith Street;

2) That said Section 301.1 of Chapter 1079 of the Ordinances of the City of Providence entitled "Building Ordinance of City of Providence" is hereby ratified and affirmed in all other respects.

3) This Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.



The attached original and six (6) copies of a proposed ordinance, including a map of the area to be deleted are transmitted for introduction at the September 2, 1971 City Council Meeting.
