

Gentlemen:

The Traffic Engineering Department has investigated the advisability of installing YIELD signs on Arnold Street at its intersection with East Street, as requested in City Council Resolution No. 208, dated March 5, 1956.

Investigation of the conditions at this intersection revealed that the volume of traffic using the intersection is quite low, and that the accident record over the last five years has been very good, with only one accident being reported in 1955.

In view of this satisfactory accident record, it is recommended that no control measures be installed at Arnold and East Street at this time.




