WHEREAS, FEMA requires that a Resolution designating an applicant's agent,

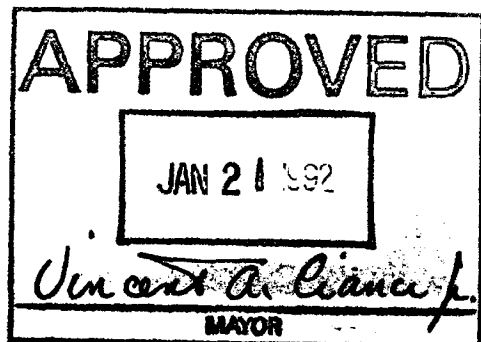
