CHAPTER 794

No. 705 **AN ORDINANCE** PROHIBITING ABANDONMENT OF ICE
BOXES AND REFRIGERATORS ACCESSIBLE TO CHILDREN.

Approved November 20, 1953

Be it ordained by the City of Providence:

SECTION 1. It shall be unlawful for any person, firm or corporation to leave outside of any building or dwelling in a place accessible to children any abandoned, unattended or discarded ice box, refrigerator or any other container of any kind which has an air-tight door, snap-lock or other locking device thereon without first removing the said door, snap-lock or lock from said ice box, refrigerator or container.

SEC. 2. Any person, firm or corporation violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be liable to a penalty as prescribed in Section 10 of Chapter 1 of the Revised Ordinances of 1946 as amended.

SEC. 3. This Ordinance shall take effect upon its passage.



No. 706 AN ORDINANCE IN AMENDMENT OF CHAPTER 544
OF THE ORDINANCES OF THE CITY OF PROVIDENCE APPROVED
SEPTEMBER 21, 1951, ENTITLED, "AN ORDINANCE ZONING
THE CITY OF PROVIDENCE AND ESTABLISHING USE, HEIGHT AND
AREA REGULATIONS."

Approved November 20, 1953

Be it ordained by the City of Providence:

SECTION 1. The Zoning Map accompanying and made a part of Chapter 544 approved September 21, 1951 entitled "An Ordinance Zoning the City of Providence and Establishing Use, Height and Area Regulations" is hereby amended by changing from a Residence R-1 Zone to a Commercial C-4 Zone that portion of lot 418 presently zoned Residence R-1 as set out and delineated on City Assessor's Plat 73; said lot being located on the easterly side of North Main Street between Edgehill Road and Dexterdale Road and designated as 977 North Main Street, bounded and described as follows:

Beginning at a point in the northerly line of Dexterdale Road at the westerly boundary of the existing Residential Zone (R-1) east of North Main Street; thence northerly along the said westerly boundary of the existing Residential Zone. (R-1) to the southerly line of Edgehill Road; thence easterly along the said southerly line of Edgehill Road to the northeasterly corner of Lot 418 on Assessor's Plat 73; thence southerly along the westerly line of Lot 550, to the southwesterly corner of said lot 550; thence westerly along the northerly line of Lot 521 to the northwesterly corner of said Lot 521; thence southerly along the westerly line of said Lot 521 to the northerly line of Dexterdale Road and the southeasterly corner of Lot 418; thence westerly along the said northerly line of Dexterdale Road to the point and place of beginning.

SECTION 2. This Ordinance shall take effect upon its passage.





SUBJECT: Referral No. 509 - ZONING CHANGE AT 977 NORTH MAIN STREET

Gentlemen:

The subject referral was considered by the City Plan Commission at a meeting held on Tuesday, June 9, 1953.

This referral is a request for a change in zoning from an R-1 Zone to a C-4 Zone that portion of Lot 418, presently zoned R-1, Assessor's Plat 73, located on the easterly side of North Main Street between Edgehill and Dexterdales Roads (977 North Main Street), said lot containing 31,067 square feet of land area.

On the field trip it was found that the area in question is presently occupied by a used car dealer (auto sales). On the rear of Lot 418 is a garage used for the repairing of automobiles. Immediately adjoining the lot in question lie two one-family houses. North of this area lies the Armory of Mounted Commands, and to the southwest lies another used car dealer (auto sales).

The granting of this petition would be highly undesirable as it would allow a considerable expansion of a C-4 use in an R-1 Zone, which in the future would hinder the adjacent properties and would further increase traffic on North Main Street, which is already a very heavily traveled traffic artery. Therefore,



METER READER I

CLASS TITLE: Meter Reader I

CLASS DEFINITION: Routine work reading and recording water meter readings on an established route; and related work as required.

DISTINGUISHING FEATURES OF WORK: Work involves the responsibility for following a prescribed route, reading meters, maintaining the record of readings and making special reports on any visible defect in meters. Daily reports are made of work done and readings are occasionally spot checked.

ILLUSTRATIVE EXAMPLES OF WORK: Follows an assigned route, reading and recording water meter readings. Ascertains that meter is not leaking, that glass is not broken and that the seal is in its proper place. Makes daily reports of readings that are taken and makes special records of any meter defects and any readings that are generally inconsistent with readings for the same period in the previous year.

DESIRABLE KNOWLEDGES, SKILLS AND ABILITIES: Ability and willingness to learn the interpretation and recordings of water meter readings. Ability to complete simple records and make simple reports. Ability to understand and carry out written and oral instructions. Ability to learn departmental rules and regulations governing the installation of water meters. Personally neat, courteous and capable of meeting the public pleasantly. Absolute reliability and honesty. Good physical condition. No serious defects in vision, hearing or members.

QUALIFICATIONS REQUIRED FOR APPOINTMENT: Preferably graduation from a standard high school. Possession of a Rhode Island State motor vehicle operator's license may be required.

USUAL LINE OF PROMOTION: To: Meter Reader II

METER READER II

CLASS TITLE: Meter Reader II

CLASS DEFINITION: Performs responsible clerical and inspectional tasks involved in the supervision of duties and records of water meter readers; and related work as required.

DISTINGUISHING FEATURES OF WORK: Work involves the responsibility for planning, assigning and supervising the work of a group of water meter readers. Assignments are general and work is reviewed only in case of complaint.

ILLUSTRATIVE EXAMPLES OF WORK: Plans, assigns and supervises the work of a group of water meter readers. Personally takes readings on meters of larger consumers and does spot check readings to verify work of subordinates. Orders or personally makes second readings on meters showing large water consumption, in comparison with previous year and notifies property owner if the reading or meter is not inaccurate.

DESIRABLE KNOWLEDGES, SKILLS AND ABILITIES: Ability to read the various types of meter registers used in the measurement of water, including straight and round registers on single, compound, Protector Fire Service and Venturi meters. Ability to plan, organize and supervise the work of meter reader and maintain production. Familiarity with the various billing districts of the water department and their respective routes and familiarity with the office procedures, and methods involved in the billing routine. Personally neat, courteous and capable of meeting the public pleasantly. Absolute honesty and integrity.

QUALIFICATIONS REQUIRED FOR APPOINTMENT: Preferably graduate from a standard high school. Extensive experience in a utility meter office, including the performance of the more complex tasks relating to meter reading. Possession of a Rhode Island State motor vehicle operator's license may be required.


