CERTIFICATION OF THE PROVIDENCE BOARD OF CANVASSERS

UNDER SECTION 208(C) OF THE PROVIDENCE HOME RULE CHARTER

TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

WHEREAS there was filed with the City Clerk of the City of Providence several papers constituting a recall petition under the provisions of Section 208(b) of the Providence Home Rule Charter; and

WHEREAS the City Clerk has referred the several papers constituting the petition to the Board of Canvassers under the provisions of Section 208(c) of the City Charter; and

WHEREAS the Board has examined all of the papers constituting the recall petition; and

WHEREAS the State Board of Elections has determined that under Section 208(b) of the City Charter at least 13,249 signatures of qualified electors are necessary to empower the City Council to order and fix a recall election; and

WHEREAS in compliance with the provisions of Section 208(c) of said Providence Home Rule Charter the Board wishes to certify to said City Council the results of its examination of said petition.

NOW, THEREFORE The Board hereby certifies that it has concluded the review of 1060 papers out of 1060 papers constituting in the aggregate the recall petition, and are unable to certify that said papers examined contain 13,249 signatures determined by the Board of Elections to be the number necessary in order to empower the City Council to order and fix a recall election.

Accordingly as of this date, we certify that the papers examined contain 9266 certified signatures of qualified electors in total, and therefore, the petition does not contain the requisite amount of 15% of all qualified electors of the City of Providence necessary.




