Whereas, A serious vehicular and pedestrian traffic problem appears to exist along Hope Street particularly at its intersection with certain streets due to increased activity.

Now, Therefore, Be It Resolved, That the Traffic Engineer be and he hereby is requested to study the advisability of causing the installation of pedestrian control traffic signal lights along Hope Street at various intersections.
