No. 409 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1984-53 APPROVED JULY 20, 1984, BY TRANSFERRING THE SUM TWELVE THOUSAND FIVE HUNDRED DOLLARS (\$12,500.00) FROM SEWER CONSTRUCTION AND MAINTENANCE PAYROLL ACCOUNT (1-005-11-001) TO SEWER CONSTRUCTION AND MAINTENANCE ITEM 269 CONSTRUCTION AND MAINTENANCE SUPPLIES (1-005-11-269).

Be it ordained by the City of Providence:

SECTION 1. Chapter 1984-53 of the Ordinances of the City of Providence, as approved July 20, 1984, entitled: "An Ordinance making an Appropriation of One Hundred Seventy-One Million, Fifty Six Thousand, One Hundred Seventy Seven Dollars and Fifty Seven Cents. (\$171,056,177.57) for the fiscal year ending June 30, 1985, as amended," is hereby further amended by transferring the sum of Twelve Thousand Five Hundred Dollars (\$12,500.00) from Sewer Construction and Maintenance payroll account (1-005-11-001) to the Sewer Construction and Maintenance item 269 Construction and Maintenance Supplies (1-005-11-269).

SECTION 2. This Ordinance shall take effect upon its passage.




RE: TRANSFER OF FUNDS
