
Stanton Street requires some patching.



This petition from the Committee on Public Works is a request for abandonment of that portion of Ponagansett Avenue which extends from Barbara Street to Melissa Street in Plat 113. The petitioner is the owner of Lots 394, 395, 396, 397, 398, 399, 400, 401, 402, 503, 404, 405 and 420 in Assessor's Plat 113 which property comprises all of the land adjoining the proposed abandonment.


Inspection revealed that all the above mentioned lots are vacant and unimproved with the exception of Lot 420 which contains the Lincoln Lace and Braid Co. factory. The portion of Ponagansett Avenue in question does not exist as a road and there is a steep embankment, which drops some 30 to 50 feet to the river bank, along the plotted path of the roadway. The nearby sections of Barbara and Melissa Streets are entirely residential and in neat, well maintained condition, a good residential neighborhood.


