

# RESOLUTION OF THE CITY COUNCIL

No. 550

Approved DECEMBER 17, 2007

WHEREAS, The Providence Redevelopment Agency ("PRA") sought the abandonment of portions of Myrtle Street and Linden Street; and

WHEREAS, Said abandonments were previously approved (Resolution No. 190 and Resolution No. 191, approved May 17, 2004); and


WHEREAS, Said Resolutions specified that petitioner was to comply with all the conditions, including recording, not later than sixty days from approval; and

WHEREAS, On June 28, 2004, in order to correct omissions in the adopted Resolutions relating to easements to be granted by the petitioner to Providence Water, Narragansett Electric, and Verizon, Deputy City Solicitor Adrienne G. Southgate wrote to Thomas E. Deller, AICP, Executive Director of the PRA, instructing him that the granting of the easements would be amongst the conditions to be imposed by the Law Department (Paragraph 4 in the Linden Street Resolution, and Paragraph 3 in the Myrtle Street Resolution); and

WHEREAS, Due to an oversight at the PRA, the easement to Narragansett Electric was not granted within the sixty-day period after passage.

NOW, THEREFORE, BE IT RESOLVED, That Resolution No. 190 and 191 approved May 14, 2004 are hereby readopted and shall be in full force and effect provided petitioner conveys the requisite easement to Narragansett Electric and records the instant Resolution not later than sixty (60) days from its approval.

# RESOLUTION OF THE CITY COUNCIL

No. 190

*Approved* May 17, 2004

RESOLVED, DECREED AND ORDERED:

That the following named street shown as cross-hatched area on the accompanying plan entitled: "Providence, RI Department of Public Works - Engineering Office, Street Line Section Plan No. 064752 dated February 4, 2004.

VIZ:

LINDEN STREET, running from Friendship Street to West Clifford Street, shown as the cross-hatched area on accompanying plan and designated by the letters (A-B-C-D), having ceased to be useful to the public, is proposed to be abandoned as a Public Highway. Said Abandonment is specifically conditioned upon the following:

- (1) Petitioner shall pay the sum of One Dollar (\$1.00) in legal U.S. tender to the City of Providence.
- (2) The petitioner shall convey a full sewer easement acceptable to City of Providence, Department of Public Works which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the Petitioner shall assume all costs of relocation.
- (3) Petitioner shall comply with all conditions contained herein, including recording this Resolution, not later than sixty (60) days from its approval. Upon failure to so comply for any reason, the within resolution shall automatically become a nullity.
- (4) Such other conditions as the Mayor or the Law Department shall see fit to impose.

And it is further

ORDERED, That the Traffic Engineer be and is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway," and it is further




To the Honorable City Council:

The Providence Redevelopment Agency hereby petitions the Providence City Council to consider the abandonment of a portion of Linden Street



The Agency requests that the abandonment be at no cost to the petitioner.






