# RESOLUTION OF THE CITY COUNCIL

No. 296

Approved MAY 24, 2007

WHEREAS, The City of Providence recognizes the benefits of clearing snow from the City's public streets; and

WHEREAS, The City acknowledges the difficulty of clearing snow from that portion of Bowen Street east of Pratt Street, and is willing to consider the benefits of having a street heating system installed for preventing snow accumulation on that portion of Bowen Street; and

WHEREAS, The City commends the generosity of Adam Edelsberg of 162 Pratt Street, Providence, who has requested permission to purchase and install a street heating system in that portion of Bowen Street east of Pratt Street and resurfacing the street after the installation.



NOW, THEREFORE, BE IT RESOLVED, That the City grants Mr. Edelsberg permission to install a street heating system within the pavement of that portion of Bowen Street east of Pratt Street, a public way, for the purpose of preventing snow accumulation.

BE IT FURTHER RESOLVED, That the portion of Bowen Street east of Pratt Street shall remain the property of the City of Providence. However, Mr. Edelsberg shall be responsible for all expenses of purchasing and installing the street heating system as well as for resurfacing the street immediately following the heating system installation. Mr. Edelsberg shall also be responsible for removal of the street heating system if the system worsens the condition of Bowen Street, and restoring Bowen Street to its pre-installation condition.





In response to your memo dated March 5, 2007, I have reviewed Mr. Edelsberg's proposal to install a street heating system in the pavement of the portion of Bowen Street east of Pratt Street and adjacent to 162 Pratt Street. I have no objection to the proposed installation based upon a clear and documented acceptance of the following:

- The cost to purchase and install the system is solely the responsibility of the owner of the property at 162 Pratt Street
- Ownership of the system remains with the property at 162 Pratt Street
- Responsibility for all costs associated with maintenance and operation of the system remains with the property at 162 Pratt Street
- Prior to installation, the installer will provide plans and specifications for the proposed system to the Department of Public Works and the Department of Inspections and Standards
- Prior to installation the installer will acquire a permit for the installation of the system
- The system will be inspected by staff for the Department of Inspection and Standards
- Upon completion of the installation the pavement restoration will be inspected by the Department of Public Works
- The property owner at 162 Pratt Street is responsible for any injury or liability that may occur as the result of the installation or operation of the system




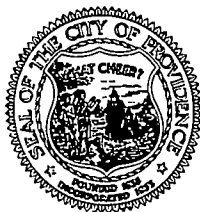
