

SUBJECT: 1983 Campaign Kick-Off Event - CAREFAIR '83

CAREFAIR '83 is the theme selected to depict this year's campaign kick-off event. As you know, we will be sponsoring a noon-time, downtown Providence agency festival where all of you will have an opportunity to creatively display the type of care and services you provide for the community.

Those of you who participated in the July 27 meeting are familiar with how the fair will be arranged. As a review, and for those who were not able to attend, here is a brief rundown of the campaign kick-off event. We have been able to confirm some of the details that were still uncertain at the time of the meeting, so we are including them now.

Theme: CAREFAIR '83

Date: Wednesday, September 14 (raindate, September 15)

Time: 11:30 a.m. to 1:30 p.m.

Location: Westminster Street (between Hospital Trust Plaza and Dorrance Street)

Space

Allocation: Each agency will be allowed a space 12 feet long by 6 feet deep. Specific space will be assigned to each agency after all registration forms have been received. You will receive a map noting where your booth will be located.

Extras: Music and entertainment will be interspersed throughout the fair displays; decorations will mark the entrance to the fair, the speaker area and special activities.

Prizes: First, Second and Third Place prizes will be awarded to the agencies with the most creative displays.

First, Second and Third Place prizes will be awarded to the companies using the most unique approach to bringing employees to the fair.
