This letter is in reference to Resolution No. 799 which was approved by the City Council on December 23, 1977:

Item 1--Kitchen: Toward the completion of construction of the Bridgham Middle School, it was decided that the Bridgham kitchen would be changed from a satellite kitchen to a preparatory kitchen. This change was brought about by a change of direction on the part of the State Lunch Program. Because of this change, additional equipment was ordered just prior to the opening of the new school, and the installation had to be made upon delivery of the equipment. All equipment has been connected properly and is operating satisfactorily.

Item 2--Vacuum Cleaners: Vacuum cleaners were ordered prior to the opening of school. As much as one was available at the time of the resolution, two more have been delivered as of this date. Naturally, this delivery was incumbent upon our going through the regular processes in the purchasing of equipment.

Item 3--Hot Water Spigot: During the course of a charrette by the community, faculty, and administration, the inclusion of a hot water spigot for hosing down the locker room floors was not brought out by any member of the group. Please be assured that since the need has arisen at this time, Mr. Alfred A. Pascale, Chief of Public Buildings, has been notified of the need for installation of a hot water spigot in the area mentioned. It is my understanding from Mr. Pascale that this item will be installed immediately.

The Bridgham Middle School is an especially fine school building--one that the residents of Providence should be proud of. I do realize that members of the City Council are aware that, in the completion of any large project such as the New Bridgham project, there would be items that would have to be adjusted so that





Approved: December 23, 1977


WHEREAS, certain conditions now exist at the New Samuel W. Bridgman Middle School, which are found to be a great inconvenience to the students, and

WHEREAS, the boys' and girls' shower rooms are inadequate for usage; a kitchen having cost Eighty Thousand (\$80,000.00) Dollars is inoperable; Twenty Nine Thousand (29,000) Square Feet of Carpeting is to be cleaned with one vacuum cleaner; the boys' and girls' locker room does not have a hot water spigot for the mopping down of the floor together with many other conditions which are found to be imperative,

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Providence hereby requests the School Committee investigate the above specified conditions at the New Samuel W. Bridgman Middle School, and

BE IT FURTHER RESOLVED, that said School Committee submit a report to the Committee on Public Welfare as to when the existing conditions will be rectified.
