RESOLUTION AUTHORIZING THE SUBMISSION OF PROJECT PROPOSALS BY THE DEPARTMENT OF PLANNING AND URBAN DEVELOPMENT FOR INCLUSION IN THE ANNUAL STATEWIDE OVERALL ECONOMIC DEVELOPMENT PROGRAM (OEDP)

WHEREAS, the Rhode Island Statewide Planning Program is responsible for the preparation of the Overall Economic Development Program which covers all qualified areas of the State and insures the eligibility for the full range of Economic Development Administration benefits under the Public Works and Economic Development Act and other Acts administered by EDA, including,

- grants to help build public facilities essential to long-range industrial and commercial growth
- financial assistance to help private enterprise expand and establish job-generating operations, and
- planning grants and technical assistance to help solve problems blocking growth, and

WHEREAS, the Public Works Employment Act of 1976, Section 108(g) states that "States and local governments making application under this Act should (1) relate their specific requests to existing approved plans and programs of a local community development or regional development nature..." and

WHEREAS, the State Planning Council has ruled that all projects proposed as amendments to the current OEDP and all projects proposed for inclusion in future OEDP's must be accompanied by a resolution of the sponsor's governing body authorizing submission of the proposal, and

WHEREAS, the Department of Planning and Urban Development has the responsibility for submitting and updating plans to the Rhode Island Statewide Planning Program for inclusion in the OEDP, on behalf of all City departments and agencies.

NOW, THEREFORE, BE IT RESOLVED THAT the Department of Planning and Urban Development is authorized to file amendments to the 1976 OEDP and make future OEDP proposal submissions for inclusion in the annual Overall Economic Development Program that is prepared by the Rhode Island Statewide Planning Program and adopted by the State Planning Council so that the City of Providence can be assured of maintaining its eligibility for the full range of benefits under Federal programs administered by the Economic Development Administration.


MEMORANDUM

TO: Mayors, Managers, Administrators, and Council Presidents
FROM: Daniel W. Varin, Secretary, State Planning Council
SUBJECT: Overall Economic Development Program
DATE: August 16, 1976

The State Planning Council adopted the annual Overall Economic Development Program for the current year on June 10, 1976. A copy of the OEDP has been mailed to you.

Some subsequent requests to amend the OEDP to include additional projects have been received, and we are aware that others are being prepared, apparently, in response to Section 108 (g-1) of the Public Works Employment Act of 1976, which states that "States and local governments making application under this Act should (1) relate their specific requests to existing approved plans and programs of a local community development or regional development nature. . . ."

At its meeting on August 12, the State Planning Council ruled that all projects proposed as amendments to the current OEDP, and all projects proposed for inclusion in future OEDP's, must be accompanied by a resolution of the sponsor's governing body authorizing submission of the proposal. For projects sponsored by a city or town, this authorization must be by the city or town council.

SUBJECT: A-95 Review of Applications for Funding Under Title I
of the Public Works Employment Act of 1976
DATE: September 1, 1976

This agency, acting in its capacity as the designated state clearinghouse under OMB Circular A-95, will as of this date initiate review of completed "Notices of Intent to Apply For Federal Aid" in accordance with section 316.11, (d)(1) of the Title I, PWE regulations issued August 23, 1976.

"Applicants must submit their full applications or notifications of intent to apply to the appropriate clearinghouse as early as possible"

Applicants may initiate the review process by submitting a completed Form RISPP-83(1-74) to this agency (copy of form and instructions attached). Only those proposals that satisfy the selection criteria as outlined in section 316.10 should be submitted for review.

All applicants are advised that this clearinghouse will base its comments and recommendations on the following.

OMB Circular No. A-95 (Revised) Part I, para. 5.

"Comments and recommendations made by or through clearinghouses with respect to any project are for the purpose of assuring maximum consistency of such project with State, areawide, and local comprehensive plans."

Title I, Public Works Employment Act of 1976, Section 316.10(a)(ii)(c)

"Relates to existing approved plans and programs of a local community development or regional development nature or promotes or advances longer range plans and programs"


In accordance with the above cited sections, all projects will be reviewed for their consistency and inclusion in:

- 1) State or local functional plans, e.g. capital development, recreation, transportation, ect., as applicable.
- 2) The 1976 Rhode Island Overall Economic Development Program (OEDP) as either a
 - (a) Top Priority Project or a
 - (b) High Priority Project

NOTE: If a proposed Title I project is not currently included in the OEDP the amendment process as outlined in the enclosed August 16, 1976 memorandum should be followed prior to requesting A-95 review.
