Resolved,

**That** the City Treasurer, acting under the direction of the Committee on Finance, be and he hereby is authorized and directed to borrow from time to time such sums as may be necessary, not exceeding ONE MILLION (\$1,000,000.00) DOLLARS in accordance with the provisions of Chapter 22 of the Public Laws, passed by the General Assembly at its January Session, A. D. 1958, and approved May 20, 1958 entitled "AN ACT AUTHORIZING THE CITY OF PROVIDENCE TO ISSUE BONDS IN THE SUM OF ONE MILLION (\$1,000,000.00) DOLLARS FOR SCHOOL MODERNIZATION", and to issue the City's notes therefor bearing interest at a rate not exceeding three and one-half percentum ( $3\frac{1}{2}\%$ ) per annum, signed by him and countersigned by the Mayor and Chairman of Finance Committee; and to renew any such notes from time to time as the same become due. The money thus obtained is hereby appropriated for and shall be used and expended for the modernizing of school buildings in said city.

Resolved,

That the City Council of the City of Provi-

dence hereby judges that public necessity requires the establishment of playground and recreational facilities in the vicinity of Narragansett Avenue and Woodmont Street, which will involve the taking of land and improvements, by the City of Providence, and that pursuant to the provisions of Chapter 1856 of the Public Laws passed at the January Session, A. D. 1947, and approved April 24, 1947, and in the exercise of the power and authority conferred by said Chapter 1856 and under the procedures authorized by Chapter 2239 of the Public Laws, 1949, and Chapter 2591 of the Public Laws, 1950, the City Council of the City of Providence hereby deems it necessary to take, and the City of Providence, a municipal corporation created by the General Assembly of the State of Rhode Island, hereby elects to take, and does take, for playground and recreation facilities, that certain tract or parcel of land situated on Narragansett Avenue and Woodmont Street in said City of Providence, shown as shaded area and designated by the letters A-B-C-D-E-F-G-H on the accompanying plan, entitled "Providence, R.I., P.W. Dept.--Engineering Office, City Property Section, Plan No. 061718, Date May 20, 1958", bounded and described as follows:

Beginning at the southwesterly corner of Narragansett Avenue and Woodmont Street; thence southeasterly and bounded northeasterly by Narragansett Avenue six hundred sixty-three and forty-five one hundredths (663.45) feet; thence southwesterly at right angles and bounded southeasterly by land now or formerly of Suren G. Dadekhian, forty-six and fifty-eight one hundredths (46.58) feet; thence westerly, making an interior angle of  $153^{\circ}-08'-15''$  and bounded southerly in part by land now or formerly of Ambrose M. Clifford and wife Agnes M. and in part by land now or formerly of Dana Bomes and in part by land now or formerly of Herbert Ward and wife Ethel and in part by other land now or formerly of Dana Bomes and in part by land now or formerly of James E. Patton and wife Elizabeth S. and in part by other land now or formerly of Dana Bomes and in part by land now or formerly of Earl F. Thayer, Jr. and wife Vivian M. and in part by land now or formerly of George B. Geer and wife Vivian I., four hundred fifty (450) feet to the easterly line of Alexander Street; thence northerly at right angles and bounded westerly by Alexander Street sixty-two and seventeen one hundredths (62.17) feet; thence northwesterly, making an interior angle of  $245^{\circ}-26'-20''$  and bounded southwesterly by the northerly termination of Alexander Street, fifty-four and ninety-seven one hundredths (54.97) feet; thence northeasterly, making an interior angle of  $96^{\circ}-48'-45''$  and bounded northwesterly in part by land now or formerly of Joseph Alia and in part by land now or formerly of Martin A. Fahey and in part by land now or formerly of John H. Harty, Jr. and in part by land now or formerly of Lester J. Lalime and wife Jane M. and in part by land now or

Boylan and wife Frances V., one hundred (100) feet to the southerly line of Woodmont Street; thence southeasterly at right angles and bounded northeasterly by said Woodmont Street, sixty and fifty-one one hundredths (60.51) feet to the southwesterly corner of Narragansett Avenue and Woodmont Street and the point and place of beginning. This last described line making an interior angle of  $139^{\circ}-57'-30''$  with the line first described herein. Said parcel contains 195,136 square feet.

All as shown on the "Statement--Plat of Land Condemned, Pursuant to the Provisions of Chapter 1856 of the Public Laws Entitled, 'An Act Establishing a Department of Recreation for the City of Providence,' Passed by the General Assembly at Its January Session A.D. 1947, Authorizing the Condemnation of Land for the Purpose of Carrying out a Comprehensive Program of Recreation and to Erect and Equip Buildings and other Playground Facilities and by and in Accordance with the Resolution of the City Council of the City of Providence Numbered 344, Approved July 3, 1958, Condemning Land for Park and Playground Purposes."

Also including all right, title and interest of the owners of said parcels in Woodmont Street, Narragansett Avenue, and Ardoene and Robert and Alexander Streets.

The City of Providence expressly exempts from this taking the poles, wires, pipes, fixtures and other removable facilities of any public utility company located in, on or above the highways or streets located within the area taken, but does not waive or relinquish any existing right to order the same relocated or removed.

That although the measurements herein given and the measurements and areas given are shown on said plat, and believed to be approximately correct, yet, all the land described and delineated as included in the taking herein or hereunder are taken whether said areas are greater or less than shown herein;

That there be filed in the Office of the Recorder of Deeds in said City of Providence a description of said lands to be acquired, and also a plat thereof, and a statement that the same are taken pursuant to the

provisions of said acts, which description, plat and statement shall be signed by the Mayor of said City.

After the filing of said description, plat and statement, the Board of Contract and Supply is hereby authorized and empowered to confer with the owner or owners of any part or parts of the land taken hereunder, and to agree in behalf of the City of Providence upon the price of the land and improvements so taken. The Board of Contract and Supply is hereby further authorized as a part of any such agreement made by it to sell to the owner or owners thereof any and all improvements upon the premises of said owner or owners, and is also authorized as a part of said agreement to convey to the owner or owners thereof any excess land which said City may acquire by reason of said condemnation from such owner or owners.

The Board of Contract and Supply is hereby authorized to determine rents and charges for the use and occupancy of any and all lands or premises condemned pursuant to the provisions of this resolution, and may designate some person to collect the rents for the City Collector of the City of Providence. Said Board may sell at public auction or private sale any and all buildings and improvements within the condemnation area, which have not been sold to the former owner or owners thereof as part of the settlement agreement hereinbefore provided, and may provide for the tearing down and removal thereof where necessary.

The cost of taking said land and property, and all costs incidental thereto incurred in carrying out the terms of this Resolution shall be charged to Recreation Loan Account II, authorized by said Chapter 2591, Public Laws of 1950.

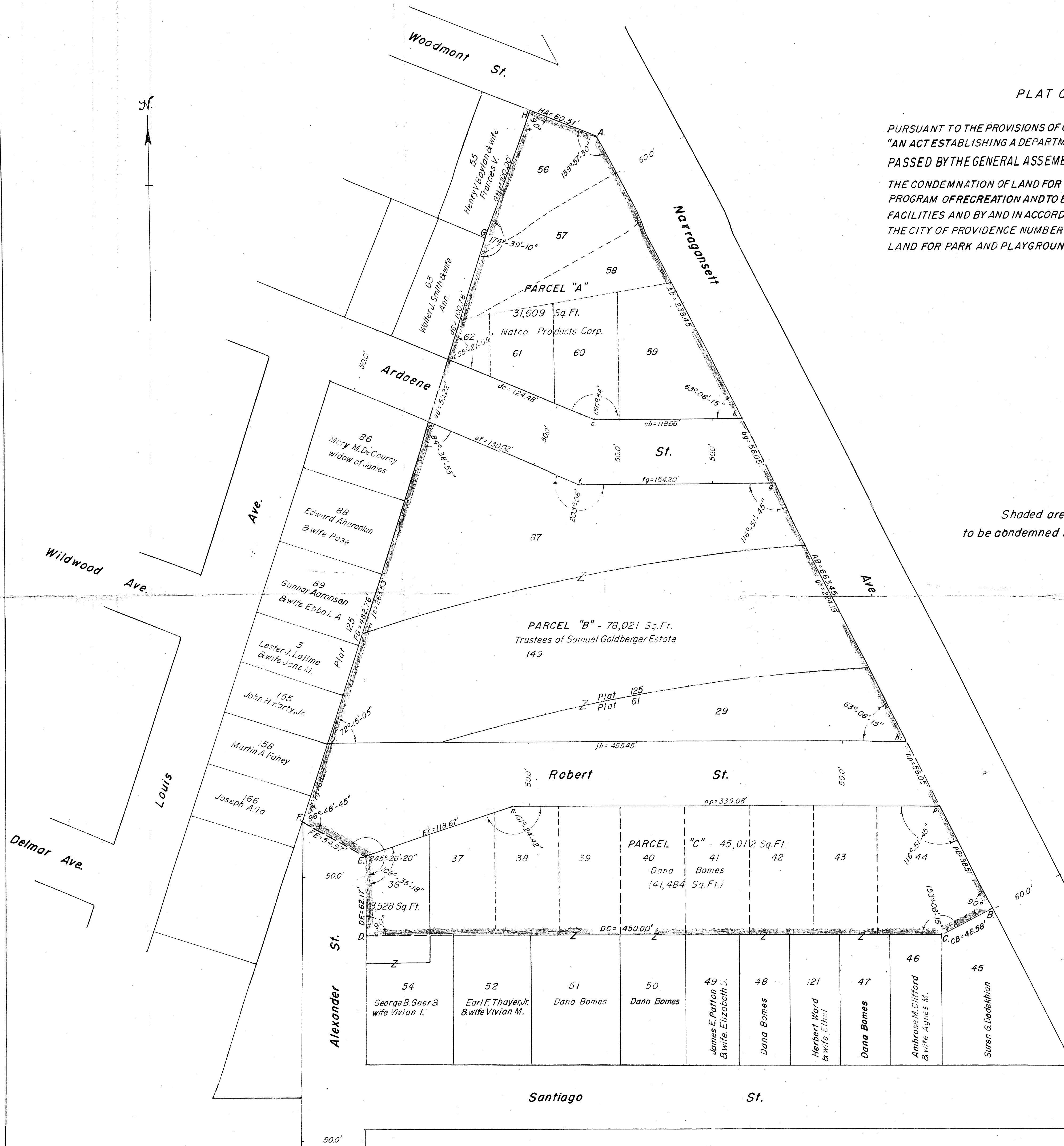

PURSUANT TO THE PROVISIONS OF CHAPTER 1856 OF THE PUBLIC LAWS ENTITLED,  
"AN ACT ESTABLISHING A DEPARTMENT OF RECREATION FOR THE CITY OF PROVIDENCE,"  
PASSED BY THE GENERAL ASSEMBLY AT ITS JANUARY SESSION A.D. 1947, AUTHORIZING

Resolved,

That His Honor the Mayor be and he hereby is authorized to execute a lease to the International Union of Operating Engineers, Local 57, of that certain area lying easterly of Gano Street, containing approximately 203,699 square feet of land and comprising Lot 566 on Assessor's Plat 14, and Lot 456 on Assessor's Plat 15; said lease to be for a period of twenty (20) years, with an option to renew for an additional period of twenty (20) years, the rental for the first twenty (20) years to be fifteen hundred (\$1500) dollars per annum. Said lease shall contain a recapture clause during the renewal period, and shall contain such other terms and conditions as may be approved by His Honor the Mayor and the City Solicitor.

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, June 10, 1958.

This referral is a request for the lease of land on Gano Street, Lot 566 on Assessor's Plat 14 and Lot 456 on Assessor's Plat 15. The area in question contains a total of 203,699 square feet.

On the field trip it was found that the area is presently vacant.

VOTED: To offer no objection to the granting of this petition providing the lease contains a recapture clause permitting cancellation by the City at such time as this area may be required for construction of the proposed River Drive.
