Dear Honorable Members:

I hereby disapprove and veto the Ordinance in

amendment of Section 21-16 of the Code of Ordinances of the City of Providence granting an extension of the appeal deadlines for the automobile excise tax.

I have taken this action because extension of the deadline for filing appeals would require an amendment to the City Charter which can only be accomplished by a Legislative enactment. Furthermore, as I previously indicated in my veto message to you of September 11, 1981, whereby I disapproved and vetoed the Ordinance in amendment of Chapter 21 of the Code of Ordinances adding Section 21-16, an excise tax is not the type of tax enumerated in Section 6.12 of the City Charter which provides for tax appeals.

PERSONAL PRIVILEGE

COUNCILMAN MANSOLILLO requests and is Granted the Privilege of the Floor and states:

"In the Providence Journal and Evening Bulletin on October 21, 1981, there was at the end of an article regarding activities of the City Council Committee Meeting, the following two paragraphs:

"The committee also refused to approve personal-property tax reductions that the tax assessor's office said resulted from "errors on the city's tax list," because the errors were not specified in each instance, according to Councilman Thomas F. O'Connor, Jr., D-Ward 11.

"Some of these names just boggle my mind", O'Connor, said reading only the name of Councilman Charles R. Mansolillo, also a Democrat from the 11th Ward. O'Connor added "It isn't just him—his father is on the list too", "I want to know what the errors were, not only in those cases, but in all cases."

The Committee agreed to request such specific information from the tax assessor's office.

I rise, my brothers and sister, to make the record clear that if there are any amongst you that have any questions regarding these errors that I might relieve you of any questions you might have. I was not present at the meeting of the Committee on Claims and Pending Suits, but this isolation by my colleague from my own Ward where I am sure he has a great deal of knowledge of my reputation in that community as did my associates in the last election, that these matters, these questions that were raised about errors and innuendos that subsequently come from that kind of reading certainly in my opinion, was out of order. The fact is that, if the records were checked, I know most of us have been through it, if not yourself, with a constituent, that multiple registrations occur when a person changes their vehicles in the midst of a year. I was taxed for 17

months on 1 car and in my father's case, he was taxed for 11 months plus 12 months, I don't know if that was just lack of information that was available because that's all on the form, the information, double taxation for my father, 17 months of taxation for myself. Well, I regret that my colleague from my own district thought that maybe there were some problems with my taxes and I received something to be changed on my taxes, because quite frankly I would never do something like that and I certainly respect and value my colleagues and would never do something like that, like I know they would never do something like that.

COUNCILMAN O'CONNOR RESPONDS:

"In fact, that document Mr. Mansolillo is pointing to was not submitted to the Committee on Claims and never had been submitted in that form. My question of many of the names that appeared on the forms was because the claim outlined several different areas to which we could not determine any of the reasons that people were getting reconsideration. One in particular was the fact that referred to the vehicles that may have been over assessed, in the opinion of the owners due to use of one book versus another book. There was a question in my mind that would have been answered had either the Tax Assessor been present or if he had in fact designated beside each name that appeared on the list as to what was the problem in each case. The information did not appear. I simply questioned why in fact there were so many names coming in under multiple headings without any explanation and I pointed out Councilman Mansolillo's name because it was founded in my mind that Mr. Mansolillo in fact, opposed the Ordinance which this Council passed to allow to appeal to Citizens in the Community who felt that they were over assessed in the assessment of their vehicles, and that was the reason that was done.

In fact, if Mr. Littler had been present or if he had provided the information that we needed to determine in each case why the over assessment or the correction was necessary then there would have been no need for us to even defer passage of those claims had it been spelled out clearly which it was not.

COUNCILMAN MANSOLILLO: Mr. President, One final comment. I regret that my name caused Councilman O'Connor's mind to be "boggled".
