ASSURANCE  
OF THE  
CITY OF PROVIDENCE, RHODE ISLAND

WHEREAS, the project for Hurricane Flood Protection in Narragansett Bay, in Rhode Island is authorized by Act of Congress approved July 3, 1958, Public Law 85 - 500 and in accordance with the plans and recommendations in House Document No. 230, 85th Congress, 1st Session, to provide for the construction of a barrier across the Providence River at Fox Point with Accessory pump, river gates, cooling-water inlet facilities and dikes at each end with street gate structures generally in accordance with the plan of the Division Engineer and with such modifications thereof as in the discretion of the Chief of Engineers may be advisable; and

WHEREAS, this project within the limits indicated on plans prepared by the New England Division, Corps of Engineers, U.S. Army, can be constructed at a cost now estimated to be Sixteen Million One Hundred and Eighty Thousand Dollars (\$16,180,000.00) and

WHEREAS, the said project is to be prosecuted under direction of the Secretary of the Army and the supervision of the Chief of Engineers, Corps of Engineers, U.S. Army; and

WHEREAS, local interests desiring the prosecution of this project are agreeable that certain assurances for local cooperation will be executed.

NOW, THEREFORE, the City of Providence in compliance with the conditions contained in the above mentioned legislation will:

- (a) Contribute 20% of the first cost of the project, said 20% being presently estimated at Three Million Two Hundred and Thirty Six Thousand Dollars (\$3,236,000.00) including the value of lands, easements, and rights-of-way;
- (b) Hold and save the United States free from damages due to the construction works; and
- (c) Maintain and operate the improvements after completion in accordance with regulations prescribed by the Secretary of the Army.

A N A C T

AUTHORIZING THE CITY OF PROVIDENCE TO ISSUE BONDS IN THE AMOUNT OF ONE MILLION (\$1,000,000.00) DOLLARS FOR THE ACQUISITION AND/OR IMPROVEMENT OF PUBLIC PARKS, PLAYGROUNDS AND RECREATION FACILITIES, INCLUDING THE PURCHASE OR CONDEMNATION OF LAND FOR SUCH PURPOSES

It is enacted by the General Assembly as follows:

Section 1. The city of Providence is hereby authorized and empowered, in addition to and not in substitution for authority previously granted, to issue, in addition to the bonds heretofore issued and now outstanding, under its corporate name and seal, serial bonds in any form which the city council of said city has heretofore approved or may approve, in an amount not exceeding one million (\$1,000,000.00) dollars. Said bonds shall be of any denomination not exceeding twenty thousand (\$20,000) dollars each, the principal thereof and the interest thereon shall be payable in any coin or currency of the United States of America, which at the time of payment is legal tender for public and private debts, and the debts incurred by said bonds shall be obligatory on said city in the same manner and to the same extent as other debts lawfully contracted by said city. The dates of maturity of said bonds shall, in no case, be more than twenty-five (25) years after date of issue; provided, however, that the first installment of the principal of the bonds issued under the provisions of this act shall mature on such dates said city council shall determine, but not later than five (5) years after the date of issuance.

Sec. 2. Said bonds shall be signed by the city treasurer, and countersigned by the mayor of the city of Providence, and shall be issued

and sold at such times and in such amount as the city council of said city shall determine; provided, however, that the premiums, if any, arising from the sale of said bonds shall be applied to the payment of the principal of said bonds in the order of their maturity. The proceeds arising from the sale of the bonds authorized by this act shall be delivered to the city treasurer, and such proceeds, except as hereinbefore provided in respect to the premiums arising from the sale thereof, shall be expended for the purpose of acquiring, developing, equipping and improving public parks, playgrounds and recreation facilities in the city of Providence, including the purchase or condemnation of land for such purposes. No purchaser of any of said bonds, however, shall be in any way responsible for the proper application of the proceeds derived from the sale thereof. The countersignature of the mayor may be by facsimile signature.

Sec. 3. The city of Providence shall annually appropriate a sum sufficient to pay the interest upon the bonds issued and outstanding under the authority of this act, and also to pay the principal of the bonds maturing in any such year, until said bonds are paid in full. All obligations of said city which are incurred under authority of this act shall be excepted from the operation of section 45-12-2 of the general laws of 1956.

Sec. 4. This act shall take effect upon its passage and shall be submitted to the qualified voters of the city of Providence at the next general or special election in said city, and said bonds shall not be issued unless a majority of the voters of said city voting thereon shall approve this legislative action.


