Gentlemen:

I wish to advise you of the following progress made upon the recommendations submitted by the Conaty Committee on June 6, 1963.

You will recall that the report's recommendations are in three general areas, "Hiring Practices", "Record-Keeping" and "Payment Procedures".

Under "Hiring Practices" the Committee included 13 of its total 28 recommendations. Of these 11 have either been already implemented or are in the process of implementation. One (no. 13) relative to preparation of a manual of personnel practices and a handbook of information for employees will require extensive research and drafting by an individual skilled in such matters. I intend to discuss this matter in more detail with the Conaty Committee. Another (no. 7) relative to flow of certain forms has been deferred also subject to further conference with the Conaty Committee upon necessary details.

Under the heading of "Record-Keeping" which contains recommendations 14 through 23 inclusive, 5 of these have already been implemented or are in preparation for implementation. The other 5 will require further discussion with the Conaty Committee for purposes of amplification.

Under "Payment Procedures" containing recommendations 24 through 28, 2 are being implemented and 1 is in the process. The remaining 2 having to do principally with the functions of the City Treasurer are being further explored.






Gentlemen:

The Providence Redevelopment Agency in accordance with the provisions of Title 45, Chapter 32, Section 48 of the General Laws of Rhode Island 1956, as amended, hereby reports concerning the proposed lease of real property within the Weybosset Hill Project No. R. I. R-7.

The Agency proposes to lease to Providence Off Street Parking, Inc. a corporation duly organized and existing as a non-profit corporation under the laws of the State of Rhode Island, that parcel of land bounded by Fountain Street, Aborn Street, Washington Street and Beverly Street in the westerly portion of the central business district of the City of Providence containing an area of approximately 43,546 square feet of land.

Providence Off Street Parking, Inc. intends to improve this site by constructing thereon a multistory parking garage containing approximately 440 parking spaces.



Gentlemen:

The Providence Redevelopment Agency, in accordance with the provisions of Paragraph 11 of Chapter 1419 of the Ordinances of the City of Providence, approved August 11, 1961, and Title 45, Chapter 32, Section 5 of the General Laws of Rhode Island, 1956, hereby reports concerning the proposed sale of real property within the Central-Classical Project No. R. I. R-2.

The Roman Catholic Bishop of Providence, the prospective purchaser, intends to erect a new St. Martin DePorres Catholic Interracial Council building, which will contain a chapel with a seating capacity for 200 people with assembly rooms and offices. Off-Street parking will also be provided for those who will utilize the proposed facility.

The Agency proposes to sell to the Roman Catholic Bishop of Providence a parcel of approximately 33,600 square feet at 20 cents per square foot for a total sale price of \$6,720.






