Mr. Clarkin will replace Theodore F. Low.





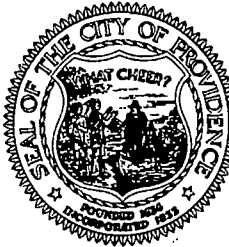
