*Whereas*, Besides his busy medical practice of almost one-quarter of a century, the good Doctor finds time to give of himself, membership on the Board of Directors of the Chamber of Commerce; Progress for Providence, Inc.; Sophia Little Home; Camps, Inc.; Fox Point Community; Catholic Social Services; St. Vincent De-Paul; Our Lady of Providence Preparatory Seminary; and Rhode Island School of the Deaf; and

*Whereas*, Doctor Mathieu has never been known to refuse participation in any worthy project; whether medical, civic, or religious, and accordingly, has gained legion of friends in the community,

*Now, Therefore, Be It Resolved*, That His Honor, Mayor Joseph A. Doorley, Jr., and the Members of the City Council do hereby congratulate Peter J. Mathieu, Jr., M.D., upon his recent election as President of the Providence Medical Association, and

*Be It Further Resolved*, That the City Clerk is directed to transmit a duly certified copy of this Resolution to him.

#### COUNCILMAN PEARLMAN:

Resolution Requesting Syria to Free All Israeli Prisoners of War in Accordance With the Geneva Accord of 1949.

*Whereas*, The Syrian Nation is in violation of the Geneva Accord of 1949, in its treatment of Israeli Prisoners of War, which has brought criticism to it from various veterans, social and political sources; and

*Whereas*, They have refused to make known their Prisoner Lists, to permit Red Cross inspections, and otherwise are in violation of all rules of humanity and civilized treatment of Prisoners of War,

*Now, Therefore, Be It Resolved*, That the Syrian Delegate to the United Nations and the Premier of Syria are hereby fervently requested that the Prisoners of War captured in the Israeli Conflict be immediately freed and returned to their native country, and that the President of the United States of America, the Secretary of State, and the Rhode Island Congressional Delegation be urged to make all adequate efforts to cause proper treatment to said Prisoners of War and all others similarly situated.

Resolution Urging that Alexander Solzhenitsyn and His Family be Permitted Freedom and Permission to Emigrate.

*Whereas*, Alexander Solzhenitsyn was imprisoned for ten years in a slave labor camp in the Soviet Union without an attorney, without a trial and without even being able to confront his accusers; and

*Whereas*, He has revealed an extensive slave

labor prison camp system containing approximately twelve million persons in Communist Russia; and

*Whereas*, Said system has caused over twenty million deaths, not to mention millions of tortures, mental breakdowns and cruelties; and

*Whereas*, It has been pointed out that the lack of applied justice in this system under the Communist rule is the most harsh, affecting the greatest number of people by death, torture and maiming in the recorded history of mankind and in the history of man's inhumanity to man; and

*Whereas*, These cruelties are a thousand times greater than those of the Czar, and even greater than the most inhumane actions of Hitler and the Nazi leaders; and

*Whereas*, Alexander Solzhenitsyn is in imminent danger of arrest and imprisonment, and possible torture and death

*Now, Therefore, Be It Resolved* That the Providence City Council go on record urging that:

1. Freedom and permission to emigrate be granted to Alexander Solzhenitsyn and his family.

2. Alexander Solzhenitsyn be treated as a hero and fighter for freedom and justice for the workingman against a tremendous bureaucracy which ignored even the legal protections of the Soviet legal system

*And, Be It Further Resolved*, That copies of this Resolution be sent to the President of the United States of America, the Ambassador to the United States of America from Russia, the American Ambassador to Russia, Secretary of State Kissinger, and to the Rhode Island Congressional Delegation to make known the concern of the Providence City Council for freedom and justice, and against oppression wherever it may exist.
