
RE: Institute for Labor Studies and Research (ILSR) Continuation of Services Proposal for FY '15 (First Source)

Dear Mayor Taveras:

The Department of Planning and Development respectfully requests approval to authorize a contract with the Institute for Labor Studies and Research (ILSR) for FY 2015. ILSR offers Providence residents a specialized training, job placement and contextualized learning program designed to meet the needs of adults 25 years + who have limited English proficiency and low literacy skills. ILSR's training is offered in a contextualized learning setting which prepares graduates for entry level employment in the hospitality sector. The training is also offered to incumbent workers and the under-employed who desire to advance their skills in order to move up in their careers and grow their wages.

This proposal seeks to build upon the success that the ILSR program has had over the past 2 years of support provided through First Source. The attached FY '15 proposal and budget outlines more specifically the service delivery model and proposed activities for the new year and seeks approval for continuation of these key services to the residents of the City of Providence. As well, ILSR has included a report on their FY '13 and '14 program and a chart of achieved outcomes. Program efforts since First Source began funding ILSR have begun to build a stronger foundation and emphasis on achieving outcomes more aligned with employment measures (i.e. jobs, wages, resume preparation, interview skills etc.)

Funding for this request will not exceed an amount of \$ 20,000 for FY '15 and will be provided through General Fund Account Code 101-908-55125-0015 (First Source) which has been budgeted for FY '15 through the Department of Planning and Development.
