OF PROVIDENCE APPROVED MARCH 26, 1982 AND ENTITLED "AN
ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT
PLAN FOR THE HARTFORD AVENUE RENEWAL PROJECT" FOR THE
DELETION OF LOT 83 ON PLAT 107 AND LOT 275 ON PLAT 114 FROM
THE ACQUISITION LIST.

Be it ordained by the City of Providence:

1. That Chapter 1982-15 of the Ordinances of the City of Providence approved March 26, 1982 and entitled, "An Ordinance approving and adopting the Official Redevelopment Plan for the Hartford Avenue Renewal Project" as amended by the following Ordinances of the City of Providence : Chapter 1986-21, approved April 24, 1986, Chapter 1991-28, approved October 10, 1991 and Chapter 1995-11, approved June 9, 1995, be and the same is hereby further amended as follows:


