## REPORTS FROM COMMITTEE

### COUNCILMAN ROBERT M. CLARKIN, Chairman COMMITTEE ON PUBLIC WORKS

**Transmits the following with Recommendation the same be Severally Adopted:**

Resolution Granting Permission to Jim Egan, Vice-President, Doran Building Condominium Association, to place planters along the sidewalk on both sides of the entryway located at 150 Chestnut Street.

*Whereas*, Doran Building Condominium Association (hereinafter "Petitioner") has sought to place decorative planters adjacent to its real estate located at 150 Chestnut Street, Providence, RI.

*Whereas*, said encroachment has been proposed in order to facilitate certain construction requirements;

*Whereas*, upon the filing of said petition by Doran Building Condominium Association, various municipal departments and public utility concerns were informed of said petitioner and their comments solicited.

*Whereas*, inter alia, the Department of Public

Works, upon investigation has found that the proposed placement of planters will not unduly impede other pedestrian traffic;

*It Is Hereby Resolved*; Petitioner is granted permission to place decorative planters not exceeding 21 inches square above references location. Said grant is specifically conditioned upon the following:

a.) Grantee shall undertake all construction in accordance with the plans submitted to the Director of the Department of Inspection and Standards; the Department of Public Works and the Department of Traffic Engineering; as the same may have been amended or modified.

b.) The Grantee shall enter into an indemnification and hold harmless agreement with the City in a form satisfactory of the City Solicitor.

c.) The Grantee shall provide insurance coverage against loss or injury in an amount not

less than (\$100,000.00) Dollars, with the City of Providence its agents, servants, officers and employees being named as an additional insured.

d.) Easements, satisfactory to those entities soliciting the same, are expressly reserved and, if necessary, Petitioner shall execute the appropriate documents to convey the same.

e.) the City shall retain a right of reverter in the premises.

Should the Grantee fail to comply with or to abide by any of the above referenced conditions, or should said encroachment cease to be used for decorative planters, the premises should automatically revert to the full fee and control of the City of Providence; any agreement hereunder shall be null and void, and any right or fee created hereunder shall be forever extinguished without recourse by the Grantee or any successor in interest.

f.) Further, the Grantee expressly agrees — which agreement shall be evidenced by the commencement of any construction provided hereunder that:

1. All documents obtained in connection with the Grantee's petition including any minutes, voice recording or transcription of the same shall compromise the official record of the Grantee's position;

2. The Grantee is presumed to assent to and comply with all recommendations, requests and the like — including but not limited to: modifications of the Grantee's original plan, landscaping alteration, set-back adjustments, rights of access to utility concerns and federal, state and municipal departments or agencies — which are contained in the official record presented to the City Council Committee on Public Works;

g.) Such other amendments or modifications as the Mayor or the Office of the City Solicitor may deem necessary to effect the purpose of this

Resolution and to promote the health and safety of the citizenry.

## PERSONAL PRIVILEGE

**COUNCILMAN CLARKIN requests the Privilege of the Floor and states:**

Recently, there were two articles in the newspaper. One informed us that building fires went up 12% over the last year. The other article stated that we were going to have another training school to hire more firefighters. There was one thing that was not in the newspaper and it was over this Holiday Weekend in the downtown business center, at least two plate glass windows, right on Westminster Street, were broken, and that graffiti was written all over buildings in this, the main center of Providence.

I wonder how many of you remember "Joe Melino?" "Joe Melino" was a non-existent non-worker on the City Payroll in the early 1960's. A paycheck was made out to "Joe Melino" each and every week even though he did no work. We in the 1990's have our own version of "Joe Melino" and it is the 80 to 100 unneeded, underworked firefighters that we have on the payroll. The only difference between "Joe Melino" and some of our firefighters is that they do exist. But like "Melino" they do no work.

Let me tell you what the 12% increase in fires really means in work load. In 1972, our Fire Department fought 1,677 building fires with less men than we have now with less injuries. Last

year they fought a total of 461 building fires, a 70% decrease — 1,216 less fires. They still want more manpower. They fought only 1.2 fires a day and that's 1.2 building fires for a 24 hour day.

Let me state again that this is a bloated, overmanned, underworked and grossly mismanaged department. There is only one reason for Minimum Manning. There is only one reason we have as big a Fire Department as we now have and it is so the Local Firefighters Union Leaders can look good to the International Union. It is so some of these leaders can grab a job with the International Union at the expense of Providence Taxpayers when they are through ripping this City off. I ask each of you, would you give up 100 firefighters if you could get 40 walking police officers? We could do this and still save Millions of Dollars. We could do this and not hurt the fire safety in this City. Forty Walking Cops, can you imagine the impact on crime with forty walking police officers? I would like to see ten walking cops at night in this Downtown Business Center.

Can you imagine what two walking cops in each of our Wards would do to crime? More firefighters are a complete waste of money. Remember firefighters don't prevent fires, they only put them out. But, the presence of a Police Officer helps stop crime.

The few businesses left in the Downtown Business Center do not need more firefighters. They need and deserve protection from crime. They need and deserve protection from vandals. People that leave the Providence Performing Arts Center or those leaving Trinity at night deserve police protection. The residents of our neighborhoods don't need more "Joe Melino's", they need and deserve good police protection. We have more firefighters today than we had in 1972. We have more firefighters than we have Police officers. Is there one of you that thinks this is right? I know I don't".

I am opposed to the new firefighter school for several reasons but the main reason is that there are no minority recruits. It is completely white and we should go back and re-advertisè and have another school. Thank You"


