Approved February 7, 1972

RESOLVED, That the City Treasurer and the City Controller are hereby authorized and directed to transfer the sum of Five Thousand (\$5,000.00) Dollars from the "Trust and Special" account of the City of Providence entitled, "Emergency Public Improvement Fund 5-580", to an account in the Capital Fund of the City of Providence known as "Public Property-Paints and Supplies 3-09".

Said sum or so much thereof as may be necessary shall be expended, under the authorizations of the Mayor and the Director of Public Property, for paints and supplies necessary to paint various buildings. Any remaining balance after completion of said work shall revert to the "Trust and Special" account of the City of Providence, entitled, "Emergency Public Improvement Fund 5-580".

RESOLUTION OF THE CITY COUNCIL

No. 77

Approved February 7, 1972

RESOLVED, that the City Council of the City of Providence, Rhode Island, United States of America, does hereby protest to Queen Elizabeth of England, and her Government, against the barbarous laws and cruel oppression inflicted upon the Roman Catholics of Northern Ireland, and against the dastardly massacre of certain of its unarmed citizens in the City of Londonderry, Ireland, on January 30, 1972, and further call upon the Crown and Government to withdraw its Occupational Troops from Northern Ireland, and

BE IT FURTHER RESOLVED, that it is hereby recommended that the said Occupational Troops be replaced by a force selected by the United Nation's Peace Contingent, and

BE IT FURTHER RESOLVED, that it is the opinion of many citizens of Irish extraction, in this City, that peace can only be permanently attained by the unification of Ireland.

NOW, THEREFORE, BE IT RESOLVED, that upon the adoption of this Resolution, a duly certified copy be transmitted to Her Majesty's Prime Minister, Edward Heath, at 10 Downing Street, London, England, and to the Prime Minister of the Irish Republic, John Lynch, at Leinster House, Dublin, Ireland.


