No. 285 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1984-53 APPROVED JULY 20, 1984, BY TRANSFERRING VARIOUS SUMS OF MONEY WITHIN THE PUBLIC SAFETY DEPARTMENT.

Be it ordained by the City of Providence:

SECTION 1: CHAPTER 1984-53 of the Ordinances of the City of Providence, as approved July 20, 1984, entitled: "An Ordinance making an Appropriation of One Hundred Seventy-One Million, Fifty Six Thousand, One Hundred Seventy-Seven Dollars and Fifty Seven Cents, (\$171,056,177.57) for the fiscal year ending June 30, 1985, as amended", is hereby amended by transferring the sum of Sixty-Four Thousand Five Hundred Eighty-Three Dollars (\$64,583.00) within the Public Safety Department. 

Dear Councilwoman Brassil:

The Finance Department respectfully requests the following transfers.

Within the Communications Department \$6,583 from the telephone account 1-003-04-111 to the Communications salary account 1-003-04-001.

Within the Fire Department \$8,000 from claims 1-003-03-331 to the salary account and \$36,000 from hydrant rentals 1-003-03-133 to the Fire salary account.

From the Commissioner of Public Safety salary account 1-003-01-001 to the Police salary account 1-003-02-001 \$14,000.

These transfers are necessary to provide funding for 6.5% pay increases for those members of the above departments who did not get the increases at the appropriate time.
