

As indicated in the enclosed letter to Councilman Lombardi, we are requesting an address change for the three buildings to be known as The Regency Plaza.

We believe that the address change will up-grade the feeling here, and bring a greater sense of continuity to the area.

We would propose that the addresses be changed so that the original and largest building which is currently "60 Broadway" (the entrance to the building is not on Broadway) be changed to "One Regency Plaza". The other two buildings will be numbered Two and Three Regency Plaza for the West and East respectively (they are currently Two and One Jackson Walkway).

This plan varies just a bit from that outlined in my letter of May 2nd. Please advise me of any additional information or requests that you may need from us.

Dear Councilman:

Chestnut Hill Realty Corporation is the managing agent for the new owners of the Regency Apartment's in Providence. I believe that the three buildings are included in your Ward.

It is the intent of the new owners to materially up-grade the three buildings over the next twelve to eighteen months. We feel that it would be most important that the three buildings be considered a "Plaza", and that the buildings have greater continuity.

Currently the original building, Regency Plaza, and the two other buildings the East and West respectively have legal addresses which do not suggest the continuity of a Plaza. The current addresses of the buildings are 60 Broadway (Regency Plaza), and One and Two Jackson Walkway for the East and West respectively.

We intend to call the entire complex the Regency Plaza and we would like to propose that the official addresses of the buildings be changed to One, Two, Three Regency Plaza. For example: East Building, One Regency Plaza, West Building, Two Regency Plaza and the original building, Three Regency Plaza.

Dear Councilwoman DiRuzzo:

In reference to the proposed resolution which would change 60 Broadway, 1 Jackson Walkway, and 2 Jackson Walkway to 1, 2, and 3 Regency Plaza, I believe that these types of changes may tend to compromise the numbering system the City of Providence now maintains.

Presently, there are approximately 16 buildings in the downtown area that have been given out-of-sequence or unique addresses. Attached is a list of these locations. If we (jointly) allow this practice, an erratic address system in the downtown area could occur which might result in chaotic conditions not only for the Postal Service, but for the City's Police and Fire Departments as well as others attempting to locate these addresses. I suggest your committee take these issues into consideration and review this resolution. Our recommendation is to retain the present address sequence.

I would like to express my appreciation for your notifying the Postal Service of the proposed resolutions for the city, and I hope our input is of assistance to you and the City Council in making a decision. If it would be beneficial, we would be more than willing to sit down to discuss this or any other address issues with you or members of your committee.
