AMENDING CHAPTER 776 BY APPROPRIATING

ONE HUNDRED TWENTY FIVE THOUSAND (\$125,000) DOLLARS TO AN ACCOUNT TO BE
KNOWN AS "DAVIS PARK PLAYGROUND ACCOUNT", ITEM 6.

Approved November 20, 1953

Be it ordained by the City of Providence:

SECTION 1: Chapter 776 of the Ordinances of the City of Providence as approved September 18, 1953, and entitled: "An Ordinance Making Appropriation of \$29,679,752.90 for the Support of the City Government for the Fiscal Year Ending September 30, 1954", is hereby amended by appropriating the sum of One Hundred Twenty Five Thousand (\$125,000) Dollars to an Account to be known as "DAVIS PARK PLAYGROUND ACCOUNT", ITEM 6.

SECTION 2: The said sum of One Hundred Twenty Five Thousand (\$125,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by One Hundred Twenty Five Thousand (\$125,000) Dollars.

SECTION 4: The City Controller and the City Treasurer are hereby authorized and directed to pay over this appropriation from the General Fund to an Account in the Trust and Special Funds entitled: "Davis Park Playground Account". Any unexpended balance remaining in this account shall revert to the General Fund.

SECTION 5: This Ordinance shall take effect upon its passage.

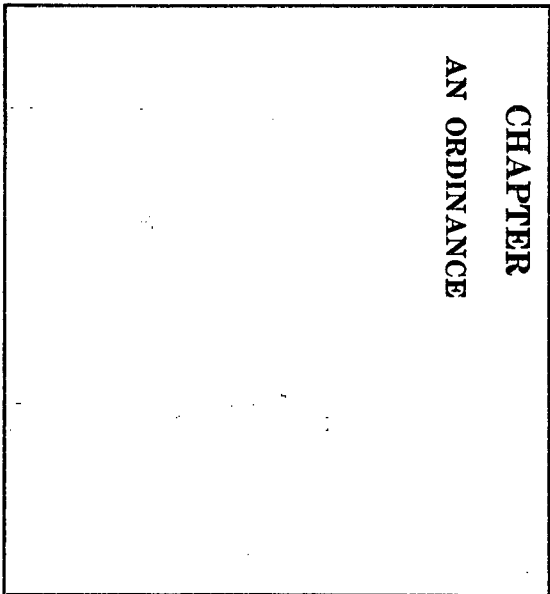

SECTION 2: The said sum of Six Thousand (\$6,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by Six Thousand (\$6,000) Dollars.

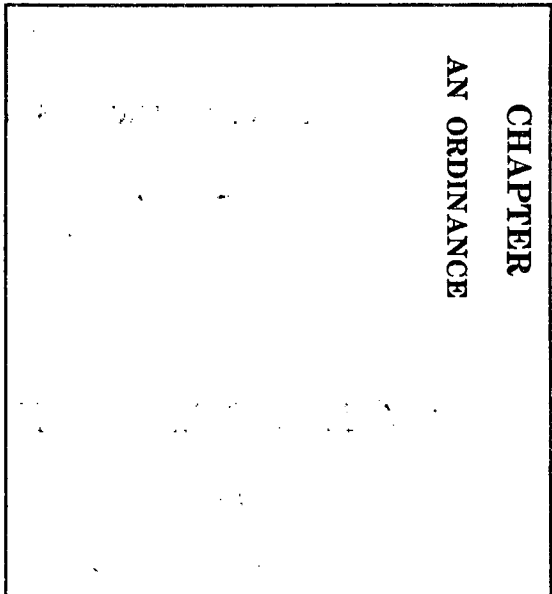

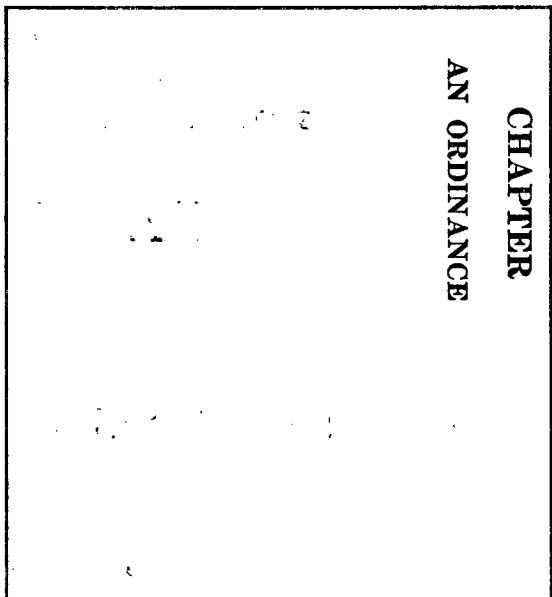
